22	act may be cited as the "Washington Metrorail Safety Commission Board of Directors
23	Appointment Amendment Act of 2017".
24	Sec. 2. Authority to appoint Members of the Board of Directors of the Washington
25	Metrorail Safety Commission.
26	Pursuant to Article III.B of section 2 of the Washington Metrorail Safety Commission
27	Establishment Act of 2016, effective April 7, 2017 (D.C. Law 21-250; D.C. Official Code 9-
28	1109.11), the District of Columbia shall appoint Members of the Board of Directors of the
29	Washington Metrorail Safety Commission as follows:
30	(a)(1) The Mayor shall appoint or reappoint (including to fill an unexpired term) one
31	Member and one Alternate Member, each of whom shall be subject to confirmation by the
32	Council pursuant to section 2(e) of the Confirmation Act of 1978, effective March 3, 1979 (D.C.
33	Law 2-142; D.C. Official Code § 1-523.01(e)).
34	(2) The Member initially appointed by the Mayor shall serve a 2-year term.

35	(b)(1) The Council shall appoint or reappoint one Member (including to fill an unexpired
36	term).
37	(2) The Member initially appointed by the Council shall serve a 4-year term.
38	Sec. 3. Section 2(e) of the Confirmation Act of 1978, effective March 3, 1979 (D.C. Law
39	2-142; D.C. Official Code § 1-523.01(e)), is amended as follows:
40	(a) Paragraph (31) is amended by striking the phrase "; and" and inserting a semicolon in
41	its place.

57	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
58	Columbia Register.
