To amend, on an emergency basis due to congressional review, D.C. Official Code § 47-2853.133 to re-establish an exemption for engaging in engineering work without a license

for employees and consultants of the District government and independent agencies who

are under the supervision of a professional engineer.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this

act may be cited as the "Engineering Licensure Congressional Review Emergency Amendment

Sec. 2. D.C. Official Code § 47-2853.133 is amended as follows:

- (a) The existing text is designated subsection (a).
- (b) A new subsection (b) is added to read as follows:
- "(b) Subsection (a) of this section shall not apply to persons acting as a consultant,

officer, or employee of the government or an independent agency of the District of Columbia

under the supervision of a professional engineer. The supervising professional engineer shall

verify that any engineering work done by such persons is in compliance with all applicable laws
