

Dear Chairman Mendelson:

Enclosed for consideration and approval by the Council of the District of Columbia is a proposed resolution entitled "Transfer of Jurisdiction over a Portion of Reservation 405, S.O. 21-07525, Emergency Approval Resolution of 2022" and an accompanying emergency declaration resolution.

The resolutions would approve the transfer of jurisdiction of approximately 126,167 square feet comprising a portion of Reservation 405 from the Department of the Interior, National Park Service to the District of Columbia. The purpose of the transfer is to facilitate the improvement and expansion of the Joy Evans Therapeutic Recreation Center.

The proposed transfer of jurisdiction was referred to Advisory Neighborhood Commission (ANC) 7B for its review on October 18, 2021. In a letter dated December 16, 2021, ANC 7B stated that it supports this transfer. The proposed transfer of jurisdiction was also referred to the National Capital Planning Commission ("NCPC"), for its review and approval pursuant to D.C. Official Code §10-111. In a letter dated November 8, 2021, NCPC notified the District of its approval of the transfer of jurisdiction.

I look forward to the Council's favorable consideration of the proposed resolutions.

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To approve, on an emergency basis, the transfer of administrative jurisdiction over a portion of Reservation 405 in the District of Columbia, from the United States of America, acting by and through the Department of the Interior, National Park Service, National Capital Area (NPS) and the Department of General Services to the District of Columbia.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this resolution may be cited as the "Transfer of Jurisdiction over a Portion of Reservation 405, S.O. 21-07525, Emergency Approval Resolution of 2022."

Sec. 2. Pursuant to Section 1 of an Act to authorize the transfer of jurisdiction over public land in the District of Columbia, approved May 20, 1932 (47 Stat. 161; D.C. Official Code §10-111), the Council of the District of Columbia approves the transfer of jurisdiction of approximately 126,167 square feet comprising a portion of Reservation 405 (part of Lot 802 in Square 5464, part of Lot 805 in Square 5465, and parts of Lots 15, 800, and 801 in Square 5467) from the United States, acting by and through the Department of the Interior, National Park Service and the Department of General Services, to the District of Columbia, as shown on the Surveyor's plat in S.O. 21-07525.

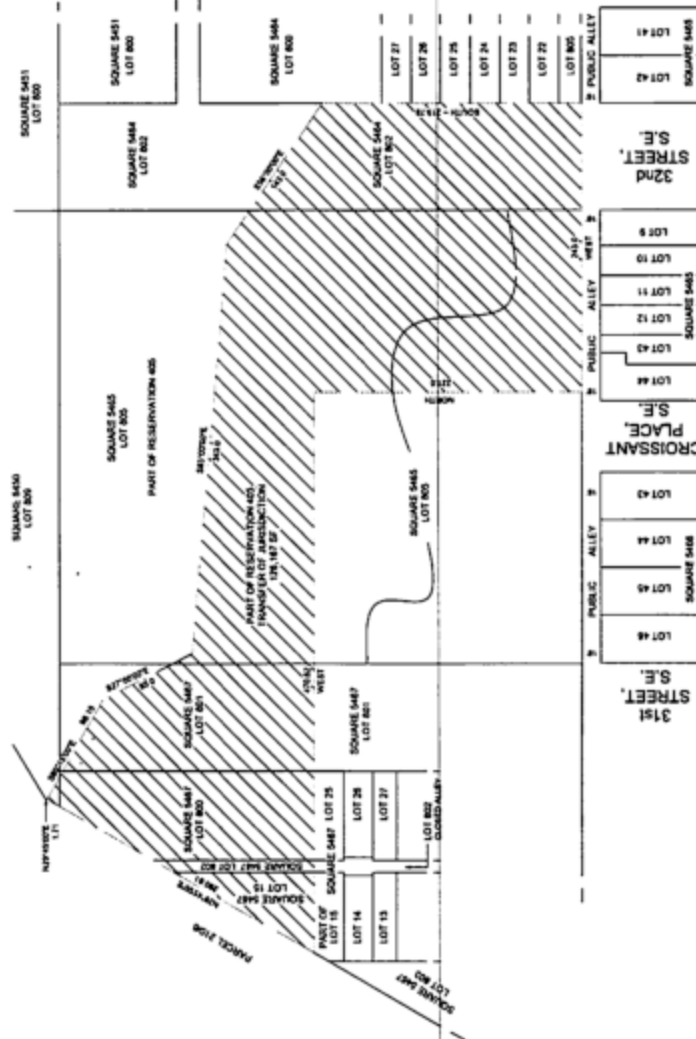

This Office has reviewed the attached proposed resolutions cited above and found them to be legally sufficient.

The D.C. Department of General Services filed an application to transfer the jurisdiction of approximately 126,167 square feet comprising a portion of Reservation 405 (part of Lot 802 in Square 5464, part of Lot 805 in Square 5465, and parts of Lots 15, 800, and 801 in Square 5467) from the United States, acting by and through the Department of the Interior, National Park Service and the Department of General Services, to the District of Columbia, as shown on the Surveyor's plat in S.O. 21-07525. The proposed transfer of jurisdiction is necessary for the construction of the new Joy Evans Therapeutic Recreation Center.

Pursuant to D.C. Code § Section 10-111, the Surveyor provided notice of the proposed transfer of jurisdiction to the National Capital Planning Commission ("NCPC") by an October 18, 2021, mailing. NCPC submitted a November 8, 2021, letter (attached) stating that NCPC, pursuant to delegated action, approved the proposed transfer of jurisdiction.

Although not required, the Surveyor also provided notice of the proposed transfer of jurisdiction to:

- Advisory Neighborhood Commission ("ANC") 7B, in which district the proposed transfer of jurisdiction is located, by an October 18, 2021, mailing;
- Various District agencies; and
- Utilities.

The responses to this notice of the proposed transfer of jurisdiction are attached.

The Office of the Chief Financial Officer submitted a March 2, 2021, Fiscal Impact Statement for S.O. 21-07525 determining that funds were sufficient in the District's Fiscal Year 2022 through Fiscal Year 2025 budget to implement the bill.

**Conclusion**

Funds are sufficient in the fiscal year 2022 through fiscal year 2025 budget and financial plan to implement the bill.

**Background**

The bill approves the transfer of administrative jurisdiction of a portion of land in Reservation 405 near the Therapeutic Recreation Center, located near 3030 G Street, S.E.<sup>1</sup> Much of the land to be transferred is already managed by the District through the issuance of Special Use Permits by the National Park Service, including a playground, baseball field and basketball court.<sup>2</sup> The District is planning an expansion of the recreation center and surrounding land, to include additional

recreational facilities and landscape features.<sup>3</sup> The transfer of jurisdiction of the entire parcel will accommodate the new facilities, and transfer management of the parcel to the District.

### **Financial Plan Impact**

Funds are sufficient in the fiscal year 2022 through fiscal year 2025 budget and financial plan to implement the bill. While most of the facilities on the parcel are already being maintained by the District, the transfer of jurisdiction will transfer responsibility for managing the entire parcel to the District. The Department of General Services has already planned and budgeted to maintain the property, as part of Therapeutic Recreation Center reconstruction process, and can manage the property within its current resources.



Pursuant to your request we have derived the most probable estimate of value for the above referenced tract of land.

The most probable estimate of value as of January 1, 2021, which represents tax year 2022, for the Transfer of Jurisdiction on Part of Reservation 405 and Part of Squares 5450, 5464 and 5467 is **\$4,602,880** (126,167 S.F. X \$36.4824 estimated square foot). The estimate is rounded and based on neighboring lots 800 and 805 of Square 5464, lot 805 of Square 5465 and lot 801 of Square 5467.

The Department of Interior, National Park Service (NPS), has submitted for approval the transfer of jurisdiction of lands to the District Department of Parks and Recreation (DPR). The Joy Evans Therapeutic Recreation Center, located at 3030 G Street, SE is sited on land previously transferred to the District from NPS. In addition, the areas adjacent to the building contain 2.89 acres of Reservation 405 that is used by DPR through a permit approval process with NPS. This land was not included in the original transfer for the recreation center. The NPS land has been used for recreational purposes in support of the Joy Evans Therapeutic Recreation Center since 1974, and DPR has submitted plans to replace the recreation center with a more modern facility and site amenities. As part of this modernization of the site, NPS is requesting approval to transfer the remaining acreage to DPR to eliminate the need for the special use permit process.

DPR proposes to replace the Joy Evans Therapeutic Recreation Center and its associated site amenities to provide a modern neighborhood recreation center that is available to all residents but is tailored for those with physical and developmental disabilities. The project includes a new 36,000-square-foot facility, playgrounds, splash pad, sensory garden and updated ball fields and walking trails. NCPC reviewed this project as File No. 8244. The existing acreage north and east of the building is currently under the jurisdiction of NPS but is maintained by DPR through a special use permit. The site is adjacent and connected to the larger Fort Dupont Park. Overall, staff finds the transfer improves the efficiency of land management for the site without any negative impact to other federal lands.

NPS and NCPC each have an independent responsibility to comply with the National Environmental Policy Act (NEPA). The National Park Service submitted a categorical exclusion C.2 regarding "Land exchanges which will not lead to significant changes in the use of the land." NCPC staff determined that categorical exclusion #7 applies, which includes the "approval of transfers of jurisdiction pursuant to 40 U.S.C. 8124 that are not anticipated to result in changes in land-use and that have no potential for environmental impact." Staff determined that no extraordinary circumstances existed prior to applying the categorical exclusion.

NPS and NCPC also have an independent responsibility to comply with the National Historic Preservation Act (NHPA). The National Park Service has submitted a determination of "No Adverse Effect" on historic resources with the stipulations that if any changes occur to the planned



stormwater management plans outside the footprint of the previously disturbed area, the Regional Archeological Program will need to be notified to determine if archaeological work is needed. The District of Columbia State Historic Preservation Office concurred with the determination. NCPC has designed NPS the lead federal agency for the purposes of complying with Section 106 of the NHPA.

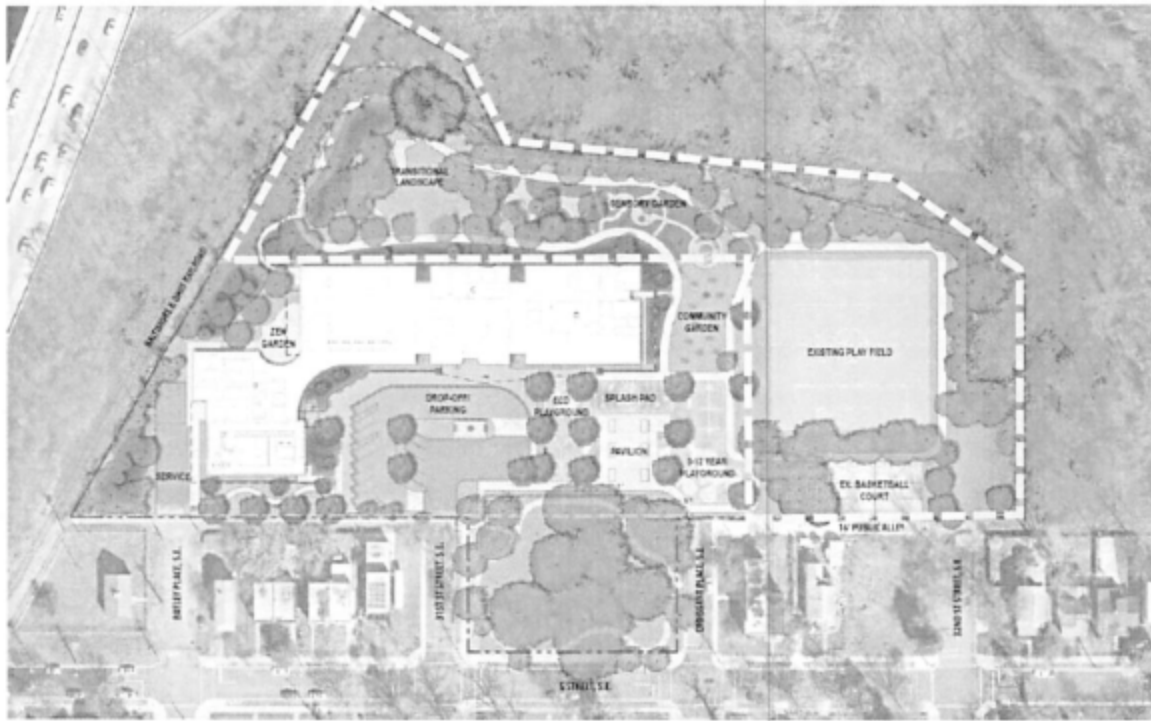


Figure 1: Proposed Recreation Center and Transfer of Jurisdiction



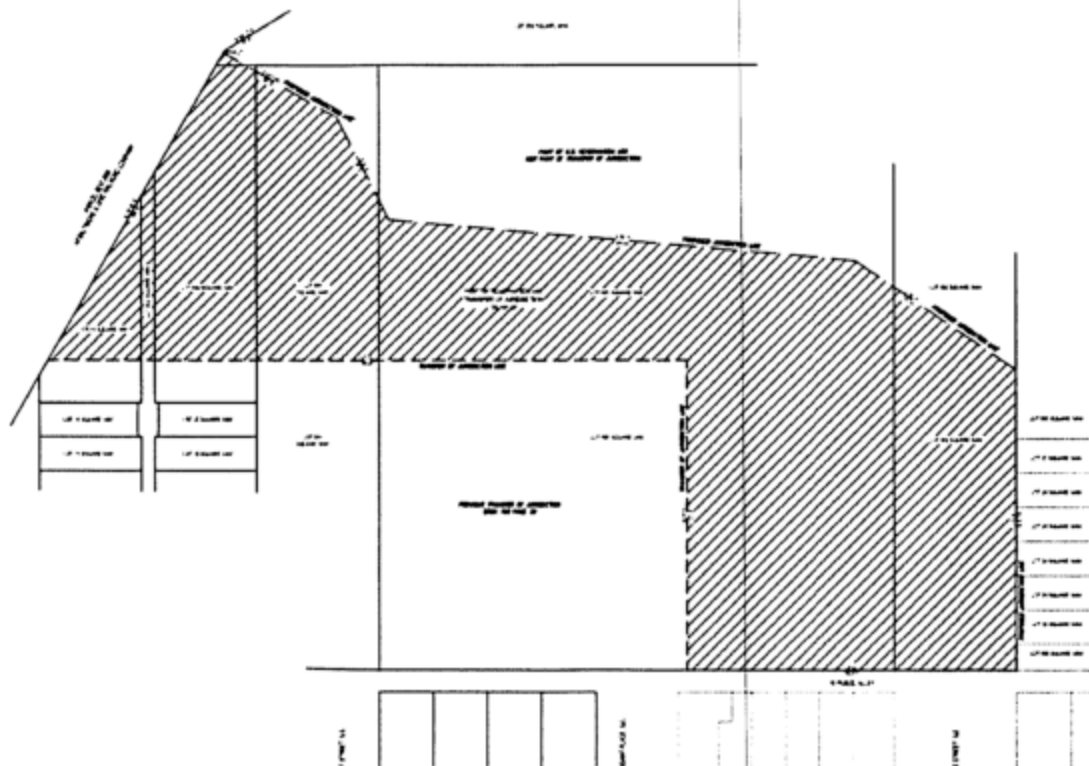


Figure 2: Proposed Transfer of Jurisdiction Plat

The Coordinating Committee reviewed the proposed transfer at their October 13, 2021 meeting. Without objection, the Committee forwarded the proposed transfer of jurisdiction to the Commission with the statement that the proposal was coordinated with all participating agencies. The participating agencies included NPS, the District Department of Transportation, the District of Columbia Office of Planning, the District of Columbia State Historic Preservation Office, the District Department of Energy and Environment, and the Washington Metropolitan Area Transit Authority.

Pursuant to delegations of authority adopted by the Commission on April 1, 2021, and per 40 U.S.C. § 8124(a), I approve the transfer of jurisdiction of lands from the National Park Services to the District Department of Parks and Recreation (DPR) at the Joy Evans Therapeutic Recreation Center at 3030 G Street, SE, to include 2.89 acres of U.S. Reservation 405.

The Office of Planning (OP) has completed its review of the application for the transfer of jurisdiction from the National Park Service (NPS) to the District Department of General Services (DGS) and has **no objection** to this transfer.

Request:	Transfer of jurisdiction of specified lands from NPS to DGS.

Comprehensive Plan:	<p>The proposal would particularly further objectives of the Land Use, Environmental Protection, Parks, Recreation, and Open Space, and Community Services and Facilities Elements of the Comprehensive Plan, in that it would facilitate a new Recreation Center building that would include a therapeutic pool, activity and therapy spaces, fitness facilities, library, a senior center, and a multi-purpose room for use by neighborhood residents. The Project would also redesign the green space around the Recreation Center by providing an updated playground and splash pad, a multi-purpose field and basketball court, a new pavilion, and sensory gardens and walking trails.</p> <p>The proposal would also further the Far Northeast and Southeast Area Element, which encourages the development of additional parks, recreation centers, playgrounds, and other facilities and programs that meet the needs of children, youth, and older adults in the community (Policy FNS-1.2.11), and aims to improve park and recreation services (Policy FNS-1.2.13).</p>

Thank you for contacting the DC Historic Preservation Office regarding the transfers of jurisdiction from the US to DC governments referenced above and listed below. We appreciate the opportunity to review this action but § 9-202.02(4) of the D.C. Code only requires the Mayor to refer applications "to close any street located on the L'Enfant Street Plan" to the Historic Preservation Review Board. We have no comment on this proposed action since it does not involve the closure of a L'Enfant Street.

We also note that we have reviewed the proposed transfers of jurisdiction in accordance with Section 106 of the National Historic Preservation Act and determined they would have "no adverse effect" on historic properties.

The District Department of Transportation (DDOT) has reviewed the submitted materials for the proposed action. This memorandum provides DDOT's assessment of the proposal.

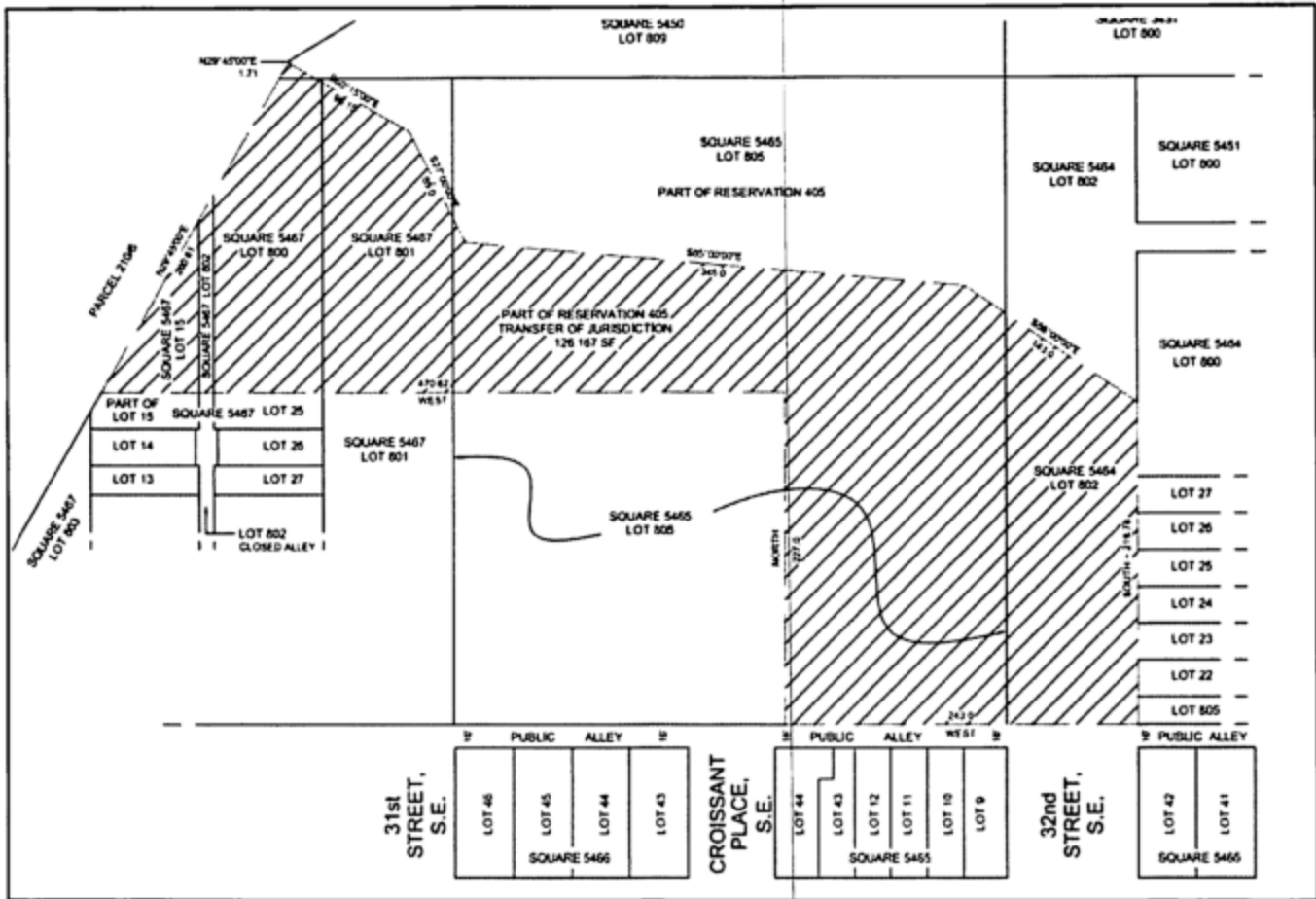
#### OVERVIEW
