Council Chairman Phil Mendelson announces a public roundtable of the Committee of the Whole on "No Shots, No School" for School year 2022-2023. This roundtable will be held on Tuesday, October 11, 2022 at 1:00pm via Zoom Video Conference Broadcast.

The purpose of this roundtable is to receive testimony from the Department of Health, the Deputy Mayor for Education, the State Superintendent of Education, the District of Columbia Public Schools, and the Public Charter School Board regarding the state of student immunizations in the District, including the COVID-19 vaccine. D.C. Official Code § 38-502 specifies that no student will be admitted to school unless the school has received certification of the student's immunization or approved exemption, and students will be subject to disenrollment if they do not meet the requirements. Enforcement is about to begin for the 2022-2023 school year. While the policy of the District is that all children should be vaccinated, it is also the policy that all children should be educated. Therefore, it is not a desired outcome for children to be disenrolled. Government witnesses are invited to update the Council and the public on the progress of implementation of the law and plans to ensure all students in the District are primed for a successful school year. The Committee is also interested whether to modify the COVID-19 vaccine mandate since the pandemic has evolved and the COVID-19 variants seem to manifest similar to the annual influenza outbreaks.

We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled.
