#### I. BACKGROUND AND NEED

Proposed Resolution 24-933, the "Students in the Care of D.C. Coordinating Committee David Domenici Confirmation Resolution of 2022," was introduced by Chairman Mendelson at the request of the Mayor on September 16, 2022 and referred to the Committee of the Whole. The purpose of PR 24-933 is to confirm the Mayor's nomination of David Domenici for appointment to the Students in the Care of D.C. Coordinating Committee (Coordinating Committee) to serve a term of four years.<sup>1</sup>

The Students in the Care of D.C. Coordinating Committee Act of 2018<sup>2</sup> created the Students in the Care of D.C. Coordinating Committee ("Coordinating Committee") which is a public body composed of engaged non-government residents and agency representatives to support planning, policymaking, program development, and budgeting for successful educational

experiences and outcomes for students in the care of D.C. The focus of the Coordinating Committee is on District residents under 25 years of age who are incarcerated or detained by, committed to and under the custody of, or otherwise under the supervision of, the Department of Youth Rehabilitation Services; the Court Services and Offender Supervision Agency; the Pretrial Services Agency for the District of Columbia; the Family Court Social Services Division; the Child and Family Services Agency; the Department of Corrections; or the Federal Bureau of Prisons.

The Coordinating Committee develops strategies and policies that guide implementation of the District's policies and programs to improve educational outcomes for students in the care of the District. The Coordinating Committee consists of 25 voting members and 4 non-voting members representing key community stakeholder constituencies and certain District agency heads or their designees. 17 members are agency heads or their designees, 8 are non-governmental members appointed by the Mayor and confirmed by the Council, and 3 are other governmental members or their designees invited by the Mayor to participate. The Coordinating Committee i be headed by a non-voting Director appointed by the Mayor.

To date, the Mayor has appointed 10 of the governmental voting members and the non-voting Director. If confirmed by the Council, this nomination will be one of the first four non-governmental voting members of the Coordinating Committee since it became effective in 2019.

Mr. Domenici earned a Juris Doctor from Stanford Law School in 1993 and a Bachelor of Science from the University of Virginia in 1986. He has been a District resident since 1992. He is a civil servant and an educator, having spent most of his adult life working in education with a focus on system-involved and at-risk teens. In 1997, Mr. Domenici co-founded the See Forever Foundation and the Maya Angelou Public Charter Schools (Maya Angelou) where he worked full-time until 2011. While at Maya Angelou, he served as Executive Director and Principal.

In 2007, Mr. Domenici was selected to open a new school at Oak Hill, which was the former name of the District's secure juvenile facility. From 2007 through 2011, he worked full-time as the principal of the Maya Angelou Academy at Oak Hill. In 2011, he left Maya Angelou to launch a 'sister' nonprofit, BreakFree Education, with the goal of supporting educational reform in juvenile justice facilities across the country. Mr. Domenici currently works at BreakFree Education and serves as a volunteer on the board of the See Forever Foundation and the Maya Angelou Public Charter School. BreakFree Education's mission is to focus on working with juvenile justice agencies and their education partners, with the goal of improving education for students held in confinement.

Based on his commitment to the mission of the Committee, his educational leadership, and his dedication to improving equitable outcomes, the Committee recommends the appointment of Mr. Domenici to the Students in the Care of D.C. Coordinating Committee. The Committee recommends adoption of PR 24-933.

#### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on five Students in the Care of D.C. Coordinating Committee nominations, including PR 24-933, on Tuesday, November 2, 2022. The testimony summarized below is from that hearing, pertaining to Mr. Domenici. Submitted copies of testimony are attached to this report.

David Domenici, Appointee, testified and answered questions from Chairman Mendelson regarding his background and experience as it pertains to the Committee and his interest in serving on the Committee. Mr. Domenici explained that he is the Founder and Executive Director of the Center for Educational Excellence in Alternative Settings. In this role, he is responsible for building consortium of state juvenile justice agencies to promote education reform in secure youth facilities. In his prior role at the See Forever Foundation/Maya Angelou Public Charter School, he served as the Founding principal of Oak Hill/New Beginnings Youth Center, the Districts long-term, secure facility for adjudicated youth. He stated his excitement to serve as a member of the Students in the Care of D.C. Coordinating Committee because he believes both his strong, long-standing work here in the District and his work around the country will enable him to support the

work of the Committee and will allow him to be able to work effectively and collaboratively with its broad range of stakeholders.

#### VI. IMPACT OF EXISTING LAW

The Students in the Care of D.C. Coordinating Committee is established pursuant to D.C. Code § 2-1599.03. PR 24-933 is an exercise of the Council's discretion to approve or disapprove Mayoral nominations to Boards and Commissions, pursuant to the Confirmation Act of 1978 (D.C. Law 2-142; D.C. Code § 1-523.01).

#### VII. FISCAL IMPACT

A Fiscal Impact Statement is not necessary for a confirmation. Committee members are not compensated for their service.

#### VIII. SECTION-BY-SECTION ANALYSIS



#### David Domenici



David Domenici is the founder and executive director of the Center for Educational Excellence in Alternative Settings (CEEAS).

Prior to starting CEEAS, Mr. Domenici worked with the Maya Angelou Schools, a network of alternative schools in Washington, DC that he co-founded. He served as the founding principal of the Maya Angelou Academy, the school located inside DC's long-term, secure juvenile facility, from 2007 to 2011. The Maya Angelou Academy's success has been widely recognized. The changes at the school were termed "remarkable" by a national expert and court-appointed monitor. The Middle States Commission's accreditation team called the Maya Angelou Academy "one of the best schools we

have ever seen." The school has been featured in local and national publications, including the Washington Post Magazine and Education Week.

Mr. Domenici is the co-author, along with James Forman, Jr., of two articles about school reform. The first, "What It Takes to Transform a School Inside a Juvenile Facility: The Story of the Maya Angelou Academy," highlights lessons learned during the start-up and first year of the Maya Angelou Academy. The second, "A Circle of Trust," chronicles the first year of the Maya Angelou Public Charter School.

A Ward 4 resident, holds a Bachelor of Arts degree from the University of Virginia and a Juris Doctor degree from Stanford Law School.

Good morning, Chairman Mendelson and members of the Committee of the Whole. My name is David Domenici and I am honored to appear before you today as a nominee of the Students in the Care of D.C. Coordinating Committee. I want to thank Mayor Muriel Bowser for nominating me to this appointment and the Council for taking the time to consider my nomination.

In the next few minutes, I want to provide the Council with a brief overview of my background and experience working in this space and answer any questions you may have.

I have lived in Washington since 1992. I practiced law briefly here in the city but have spent most of my adult life working in education, with a focus on system-involved and at-risk teens.

In 1997, I co-founded the See Forever Foundation and the Maya Angelou Public Charter Schools (Maya Angelou), where I worked full-time until 2011. While at Maya Angelou, I served as the executive director and principal for many years.

In 2007, Maya Angelou was selected to open up a school at Oak Hill, which was the name of D.C.'s secure juvenile facility at that time. From 2007 through 2011, I worked full-time on site, as the principal of the Maya Angelou Academy at Oak Hill and was also serving in that capacity when Oak Hill became what is now known as New Beginnings.

In 2011, I left the staff at Maya Angelou to launch a 'sister' nonprofit, BreakFree Education, with the goal of supporting educational reform in juvenile justice facilities across the country.

I currently work at BreakFree Education, and serve as a volunteer on the board of the See Forever Foundation and the Maya Angelou Public Charter School.

My work at See Forever Foundation, Maya Angelou Public Charter Schools and BreakFree Education provides me with a solid understanding of the issues that the Students in the Care of DC Coordinating Committee is charged with addressing.

We founded Maya Angelou in order to fill a need in the city for a high-quality alternative high school for court-involved and other students who were not being well-served. At BreakFree Education, we similarly focus on working with juvenile justice agencies and their education partners, with the goal of improving education for students held in confinement.

I'm excited to serve as a member of the Students in the Care of D.C. Coordinating Committee. I believe both my strong, long-standing work here in DC and my work around the country will enable me to support the work of the Committee and will allow me to be able to work effectively and collaboratively with its broad range of stakeholders.
