Chairman Phil Mendelson announces a public roundtable before the Committee of the Whole on PR 24-1050, "District of Columbia State Athletics Commission Larry Carroll Confirmation Resolution of 2022" and PR 24-1051, "District of Columbia State Athletics Commission Sarah Navarro Confirmation Resolution of 2022." The roundtable will be held at 10:00 a.m. on Thursday, December 8, 2022, via Zoom videoconference.

The stated purpose PR 24-1050 is to confirm the reappointment of Larry Carroll to the District of Columbia State Athletics Commission ("Commission"). The stated purpose of PR 24-1051 is to confirm the appointment of Sarah Navarro to the Commission. The District of Columbia State Athletics Commission is an independent agency that oversees the District of Columbia State Athletic Association (DCSAA). DCSAA is an association of District of Columbia public, public charter, and independent schools (private and parochial). DCSAA participants share knowledge and best practices to enhance student-athlete achievement through athletic programming and to provide quality life-learning experiences. The purpose of this roundtable is to receive testimony from the nominees and public witnesses as to the fitness of the nominees for service on the Board.

We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled.
