I. BACKGROUND AND NEED

On November 14, 2022, PR 24-1067, the "Metropolitan Washington Airports Authority Board of Directors Michele Hagans Confirmation Resolution of 2023" was introduced by Chairman Phil Mendelson at the request of Mayor Muriel Bowser. As of the beginning of Council Period 25, the measure was redesignated as PR 25-31. PR 25-31 would confirm the Mayor's nomination of Dr. Michele Hagans for appointment to the Metropolitan Washington Airports Authority Board of Directors for a six-year term expiring January 5, 2029. Ms. Hagans is currently a resident of Ward 4.

The Metropolitan Washington Airports Authority ("MWAA") was created in 1987 to assume control of Washington Dulles International Airport and Washington National Airport (later renamed Ronald Reagan Washington National Airport). The airports were formerly run by the U.S. Department of Transportation and the Federal Aviation Administration. MWAA is an Committee of the Whole Report on PR 25-31

independent body created through an interstate compact between the Commonwealth of Virginia and the District of Columbia.

In addition to the two airports, MWAA also operates, maintains, and controls the Dulles Toll Road and the Dulles Access Road. In 2008, Virginia officially transferred control of the Toll Road to MWAA in order for MWAA to construct an extension of WMATA's rail line, known as the Silver Line, connecting the region to Tysons Corner and Dulles Airport. The first phase of the Silver Line opened in July of 2014, with the second phase currently under construction and expected to open in 2021. MWAA's other major infrastructure project currently underway is the \$1 billion Project Journey at Ronald Reagan National Airport. Slated for completion in 2021, the project will add a new 14-gate concourse to replace commuter Gate 35X, and new two new security checkpoints above the arrivals level that will replace the existing checkpoints. The new checkpoints will place most of National Hall post-security, allowing for free movement between Concourses B/C and the new concourse.

The Metropolitan Washington Airports Authority Board of Directors (the Board) governs the activities of MWAA. It is composed of 17 members: seven members appointed by the Governor of Virginia, four members appointed by the Mayor of the District of Columbia, three members appointed by the Governor of Maryland, and three members appointed by the President with the advice and consent of the Senate. Board terms are for six years and members may not hold over and may not serve after the expiration of a term but may be reappointed. However, each member is limited to a maximum of two terms. All members must reside within the Washington Standard Metropolitan Statistical Area except for the President's appointments, each of whom must be a registered voter of a state other than Virginia, Maryland, or the District.¹ These provisions are the result of changes required by Congress 2012 that increased the number and allocation of seats, prohibited the holding over of a seat, and limited reappointment.²

Michele Hagans is president of Fort Lincoln New Town Corporation and Fort Lincoln Realty Company. Ms. Hagans earned a Bachelor of Science, a Master of Engineering, a Master of Divinity, and a Doctor of Ministry from Howard University, as well as a Master of Business Administration from George Washington University.

Ms. Hagans is an entrepreneur with extensive experience in the commercial development field. As an individual developer and certified property manager, Ms. Hagans has served as the president of Hagans Development Company, Inc. Ms. Hagans was instrumental in redeveloping the Fort Lincoln "Gateway" community. She serves on a number of community and business affiliated boards including Delta Sigma Theta Sorority, Inc., the Federal City Council, and Howard University. She was previously the Chair of the Board of EventsDC where she had a focus on promoting the District as a world-class destination and generating economic and community benefits for residents. In addition, she previously served as General Manager of Public Parking Facilities at National Airport.

The Committee of the Whole has received no testimony or comments in opposition to Ms. Hagans's appointment. At the December 22, 2022 hearing on her nomination, Ms. Hagans

testified about her qualifications and her willingness to serve on the MWAA Board. She also spoke to the importance of promoting more opportunities for District businesses including employment opportunities for District residents. She noted that the opening of Metro's Silver Line to Dulles Airport provides an opportunity for District residents to take advantage of employment operations in the region, including at Dulles.

Ms. Hagans has relevant professional experience that will be a benefit to the MWAA Board and also has extensive experience serving successfully on a number of other Boards. The Committee supports the nomination and recommends adoption of PR 25-31.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on PR 25-31 on Thursday, December 22, 2022. The testimony is summarized below. Copies of written testimony are attached to this report.

Warner Session, Member, Metropolitan Washington Airports Authority Board of Directors, testified in support of the nominee, citing Ms. Hagans' skills and background relevant to the functions of the Board. He described the work of the Board and detailed the time commitments and responsibilities of the Board.

Greg O'Dell, Public Witness, testified to his past work with Ms. Hagans at the District's convention center authority and her skillset's relevance to the work of the Board. He also testified to her leadership abilities and ability to work with others.

Michele Hagans, Nominee, testified about her background and willingness to serve on the MWAA Board and her focus on business and employment opportunities for District residents.

The Committee received no testimony or comments in opposition to PR 25-31.

VI. IMPACT ON EXISTING LAW

Members of the Metropolitan Washington Airports Authority Board of Directors are appointed pursuant to section 5 of the District of Columbia Regional Airports Authority Act of 1985, effective December 3, 1985 (D.C. Law 6-67; D.C. Official Code § 9-901 *et seq.*), as amended by D.C. Law 19-222, which establishes the Board, and in accordance with section 2 of the Confirmation Act of 1978, effective March 3, 1979 (D.C. Law 2-142; D.C. Official Code § 1-523.01).

VII. FISCAL IMPACT

The approval of PR 25-31 will have no fiscal impact. Members are not compensated by the District government and the operations of the Airports Authority are self-funded.

Her record of community service is equally impressive, presently serving on numerous boards including the Howard University Board of Trustees and the Virginia Theological Seminary Board of Trustees. Most recently, she served as President of the DC Building Industry Association, having led that organization from 2020 to 2022, providing steady leadership during the pandemic. Many of us in the business community have benefitted from her leadership.

Moreover, I want to note, in particular, that Rev. Dr. Hagans previously served as General Manager of the Public Parking Facilities at Reagan National Airport. In that role she had responsibility for over 5000 parking spaces and overall facilities that generated income in excess of \$10 million annually. So, her participation in the Reagan National Airport economy will not be new.

Finally, Rev. Dr. Hagans joins the MWAA Board at a good time. Despite having been disrupted by the pandemic, MWAA is in good place. This year, we cut the ribbon on the Silver Line and transferred it to WMATA. Our passenger traffic at both Dulles and National is coming back strong, exceeding 80% of the 2019, prepandemic level. We have received nearly \$50 million in competitive grants to help with capital improvements at Dulles airport. We launched "MWAA in your Community" awareness and education program to improve small business certification and MWAA is building out its Office of Diversity, Inclusion and Social Impact Team. We will also have 25 new concessions coming online next year and we are also looking to monetize our real estate assets at Dulles.

Even with all of these accomplishments in this past year, there is always room for improvement. With Rev. Dr. Hagans joining the Board, I expect that MWAA will increase the number of minority businesses participating in contracts and, in particular, District-based businesses, as well as increase job opportunities for District residents.

I know that Rev. Dr. Hagans is up to the task.

Good morning, Chairman Mendelson and members of the Committee of the Whole. I am Michele V. Hagans, and it is with pleasure and humility that I testify before you in support of my nomination to the Metropolitan Washington Airports Authority ("MWAA") Board of Directors. I am deeply grateful to Mayor Muriel E. Bowser for nominating me and honored by the Mayor's confidence in me. As a native Washingtonian, I am committed to serving the District of Columbia and its residents as a newly appointed MWAA Board of Directors member.

The entirety of my life's work has been dedicated to the District of Columbia and its residents. For nearly 40 years, I have served as the President of Fort Lincoln New Town Corporation. In that role, I have built more than 2,000 housing units, with nearly 800 of those designated as senior citizen housing. And with the opening of the Shops at Dakota Crossing, I expanded food and retail options in Ward 5 and the city, which is expected to generate more than \$700,000,000 in tax revenues for the District of Columbia over the next 30 years.

As a complement to my professional work, I have an extensive record of community service. I serve on the Board of Directors for the following organizations: The Compass Rose Society, Delta Sigma Theta Sorority, Inc., DCBIA, and HEROES, Inc. I also serve on the Board of Trustees for the following organizations: Federal City Council, Howard University, Tugaloo College, and the Virginia Theological Seminary.

I also previously served as the Chair of the Walter E. Washington Convention Center Board of Directors and chaired the Board of Trustees of the University of the District of Columbia. I have also served on the boards of Venture Philanthropy Partners, Inc., and Living Classrooms of the National Capital Region. I am a standing member of the Economic Club of Washington, the World Presidents' Organization, and the International Women's Forum of Washington.

In addition to all my community service work, I hold four degrees from Howard University: a Bachelor of Science, a Master of Engineering, a Master of Divinity, and a Doctorate of Ministry, and an MBA from George Washington University.

While I am most known for my work developing Fort Lincoln New Town, as a partner in Metro Center Associates, I developed three office buildings, a Macy's Company Department Store (formerly Hecht's), and a Marriott Hotel (formerly Holiday Inn Crown Plaza Hotel). With Tivoli Partners LLC, I developed Tivoli Square, which is a mixed-used development incorporating retail, office, residential, and the arts in the heart of the Columbia Heights neighborhood in Washington, DC. Also, as a member of NBL Associates Limited Partnership, developed a mid-rise office building located at 800 9th Street, SW. Something that very few know about me is that prior to assuming the helm at Fort Lincoln New Town Corporation, I was the general manager for the parking concession at what was known then as the Washington National Airport.

Of all my experiences, I believe being an entrepreneur, and former Chair of the Convention Center Board will serve me well as an MWAA board member. First, as an entrepreneur, I fully understand supply and demand. The demand for access to the National Capital Region has grown and continues to grow. MWAA will need to continue to work toward sustainable and steady growth in passenger load and cargo handling at both Ronald Reagan Washington National Airport and Washington Dulles International Airport. Second, as the former Chair of the Convention Center Board, I know MWAA must continue its commitment to providing world-class transportation facilities and services at both airports to better serve the District and the National Capital Region. I intend to support MWAA's President & CEO, Jack Potter, and his team in achieving those important goals.

As a member of the MWAA Board of Directors, I also intend to join my fellow DC appointees in ensuring the interests of the District of Columbia are fully represented, performing appropriate management oversight of the organization, and encouraging MWAA to make DC businesses aware of available contracting opportunities and District residents are aware of employment opportunities at the Authority. Finally, I want to support MWAA's goal of being an economic driver for the District of Columbia.

The opportunity to serve our city on the Metropolitan Airports Authority Board of Directors is a continuation of my commitment to the District of Columbia and my life's work. I look forward to the challenge, believe I am up to the task and with the insight of our Mayor, believe the National Capital Region will continue to be a desired destination.
