Council Chairman Phil Mendelson announces a public hearing before the Committee of the Whole on **Bill 25-189**, the "Commission on the Arts and Humanities Acting Executive Director Amendment Act of 2023" and **PR 25-135**, the "Commission on the Arts and Humanities Aaron Myers Confirmation Resolution of 2023." The hearing will be held at **Noon on Thursday, March 30, 2023** (or immediately following the preceding hearing).

The stated purpose of Bill 25-189 is to amend the Commission on the Arts and Humanities Act to provide procedures to fill a vacancy in the position of Executive Director of the Commission. The stated purpose of PR 23-135 is to confirm the appointment of Aaron Myers Executive Director of the Commission to fill an unexpired term ending September 30, 2024. The Commission is an independent agency that consists of 16 members. Its role is to evaluate and initiate action on matters relating to the arts and humanities and to encourage programs that promote progress in the arts and humanities.

Testimony is limited to four minutes.
