A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To officially designate, on an emergency basis, Good Hope Road, SE, between Anacostia Drive, SE, and Alabama Avenue, SE, as Marion Barry Avenue, SE; to symbolically designate Marion Barry Avenue, SE, between the intersection of Naylor Road, SE, and 25th Street, SE, and Alabama Avenue, SE, as Good Hope Way; and to require the District to reissue certain documents to individuals and entities with new addresses on Marion Barry Avenue, SE.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “Marion Barry Designation Emergency Act of 2023”.

Sec. 2. (a) Pursuant to section 401 and notwithstanding section 421 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code §§ 9-204.01 and § 9-204.21), the Council designates Good Hope Road, SE, between Anacostia Drive, SE, and Alabama Avenue, SE, as depicted in the plat in the committee report, as “Marion Barry Avenue, SE”.

(b) Pursuant to section 401 and notwithstanding section 423 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code §§ 9-204.01 and 9-204.23), the Council symbolically designates the portion

37 of the newly designated Marion Barry Avenue, SE, between the intersection of Naylor Road, SE,
38 and 25th Street, SE, and Alabama Avenue, SE, as “Good Hope Way”.

39 Sec. 3. Notwithstanding any other provision of law, the District shall reissue at no charge
40 the following documents to any individual or entity having an address on Good Hope Road, SE,
41 as of July 1, 2023, to reflect the designation of Marion Barry Avenue, SE:

42 (1) Business licenses issued by the Department of Licensing and Consumer
43 Protection;

44 (2) Professional licenses issued by the Department of Licensing and Consumer
45 Protection;

46 (3) Driver’s licenses and identification cards issued by the Department of Motor
47 Vehicles; and

48 (4) Motor vehicle registrations issued by the Department of Motor Vehicles.

49 Sec. 4. Applicability.

50 This act shall apply as of July 1, 2023.

51 Sec. 5. Fiscal impact statement.

52 The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
53 statement required by section 4a of the General Legislative Procedures Act of 1975, approved
54 October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

55 Sec. 6. Effective date.

56 This act shall take effect following approval by the Mayor (or in the event of veto by the
57 Mayor, action by the Council to override the veto), and shall remain in effect for no longer than
58 90 days, as provided for emergency acts of the Council of the District of Columbia in section
59 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;
60 D.C. Official Code § 1-204.12(a)).
