I. BACKGROUND AND NEED

On October 4, 2021 Bill 25-111, the "Rev. Lloyd N. Young Court Designation Act of 2023" was introduced by Chairman Mendelson and Councilmembers Allen and Gray to officially designate the public alley within Square 4546, bounded by 17th Street, N.E., E Street, N.E., 18th Street, N.E. and D Street, N.E. as Rev. Lloyd Young Court, N.E. The location is in Ward 7. An official naming typically involves the designation of postal addresses and enables the placement of the primary entrance to residences or offices.

Official Naming

Rev. Lloyd Young Court is the proposed name for an alley system that with an internal developable lot. The owner of the lot seeks a name for the alley in order to obtain the necessary District agency approvals for a by-right development to replace a warehouse with an alley dwelling. Lloyd Young was born in Washington on November 21, 1895. He attended the Howard University School of Religion and the Washington Baptist Seminary, licensed as a minister in 1923, and ordained in 1928. Rev. Young served for two years as pastor of the Central Baptist Church and eventually became pastor of the Greater Mount Pisgah Baptist Church as well as a

guest pastor at a number of area churches. Rev. Young served in the U.S. Army in France during World War I. He retired from the church in 1957 after serving has pastor for 27 years. He passed away on May 29, 1980 at the age of 84.

Legal Background

The Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code § 9-204.01 *et seq.*) ("Act") establishes procedures for closing streets and alleys, opening new streets and alleys, naming public spaces, and other procedures related to streets and alleys. Specifically, the Act authorizes the Council to symbolically or officially designate or change the name of any public space in the District of Columbia, including streets and alleys. In October 2016, the Act was amended to create a clear distinction between official and symbolic street and alley namings and to establish distinct processes and requirements for each type of naming.²

An "official name" refers to the legal designation of an alley or a street for mailing address and other purposes,³ whereas a symbolic name for a street or alley shall be in addition to and subordinate to any name that is an official name.⁴ Streets that do not form an essential part of the rectangular system of streets shall be named after a prominent local feature in their vicinity, or by such other distinguishing designation as the Council may determine to be appropriate.."⁵ "Rev. Lloyd Young Court" will be an official street designation.

The Act also establishes notice requirements for official designations. First, at least 15 days, but not more than 60 days prior to the scheduled public hearing, the initiator of the proposed designation shall: 1) give written notice of the date, time, and location of the hearing to each owner of property and household occupying property that abuts the alley or street, or portion thereof, proposed to be designated with an official name; and 2) post signs that indicate the date, time, and location of the Council hearing at each intersection with any other alley or street of the portion of the alley or street proposed to be designated. The initiator shall certify to the Council that the notice required has been given. Second, at least 30 days prior to the scheduled public hearing, the initiator shall submit a copy of the proposed legislation for review and comment to each Advisory Neighborhood Commission ("ANC") in which the portion of the alley or street to be designated is located. Third, at least five days prior to the hearing, the initiator shall submit to the Council letters or a petition in support of the proposal that have been signed by a majority of the owners of property and households occupying property that abuts the portion of the alley or street proposed to be designated with an official name.

Lastly, prior to consideration of a designation by the Council, the Mayor shall provide to the Council a surveyor's plat of the alley or street and adjacent properties. ¹⁰

Regarding Bill 25-111, the spirit of the notice and posting requirements were met by the initiator. The initiator worked with the local Advisory Neighborhood Commissioner to select a name that will affect only the lot owned by the initiator. ¹¹ Therefore, the Committee recommends adoption of the Bill 25-111, notwithstanding the notice requirement.

After the official street or alley designation legislation becomes law and all conditions required by the Council and the Act have been satisfied, DDOT will install signage indicating the official name of the alley or street or portion thereof, and remove signs, if any, with a previous name. The Mayor shall update relevant records of the District of Columbia to reflect the official name of an alley or street, or portion thereof, including: Fire and Emergency Medical Service records, Homeland Security and Emergency Management records, District of Columbia maps, and any other record that the District of Columbia uses for way-finding or address purposes. Mayor shall also notify the United States Postal Service, other relevant government agencies as determined by the Mayor, and relevant private sector entities. Additionally, the Surveyor of the District of Columbia shall record a copy of the legislation and the Surveyor's plat in the Office of the Surveyor.

Officially designating this alley as Rev. Lloyd Young Court, N.E. will allow for the construction of an alley dwelling and will honor Rev. Young who was an upstanding community member. For these reasons, the Committee of the Whole recommends the approval of Bill 25-111, the "Rev. Lloyd N. Young Court Designation Act of 2023."

III. POSITION OF THE EXECUTIVE

Brant Miller, Interim Manager, Policy and Legislative Affairs Division, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the street naming in Bill 25-111.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no comments from Advisory Neighborhood Commissions.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public hearing on several bills, including Bill 25-111, on March 14, 2023. The testimony summarized below pertains to Bill 25-111.

Dan Emerine, Manager, Policy and Legislative Affairs, District Department of Transportation, testified on behalf of the Executive that it had "no objection" to the designation.

The Committee also received written testimony in support of the designation which is attached to this report.

VI. IMPACT ON EXISTING LAW

Bill 25-111 has no impact on existing law. D.C. Official Code § 9-204.01¹⁶ authorizes the Council to designate any public space. D.C. Official Code § 9-204.02 authorizes the Council to designate an official name for a street." Further, the Act provides that, with limited exception, no public space shall be named in honor of any living person or in honor of any person who has been deceased less than two years. ¹⁸

VII. FISCAL IMPACT

According to the September 30, 2022 Fiscal Impact Statement of the Chief Financial Officer, funds are sufficient in the fiscal year 2022 budget and proposed fiscal year 2023 through fiscal year 2026 budget and financial plan to implement the provisions of the proposed legislation.

Good morning, Chairman Mendelson, members of the Council, staff, and District residents. My name is Brant Miller, Interim Manager of the Policy and Legislative Affairs Division at the District Department of Transportation, commonly referred to as DDOT. I am here today to present testimony on behalf of Mayor Muriel Bowser and DDOT Director Everett Lott regarding the following bills:

- B25-70, the "St. Augustine School Way Designation Act of 2023"
- B25-111, the "Rev. Lloyd N. Young Court Designation Act of 2023"

The stated purpose of **Bill 25-70** is to symbolically designate the 1400 Block of V Street, N.W., in Ward 1, as *St. Augustine School Way*. For visualization purposes, I have attached to this testimony a copy of a DDOT-generated map highlighting the 1400 block of V Street, N.W.. In fiscal terms, the cost of each installed sign for this designation is approximately \$190 (\$65 for sign fabrication and \$125 for sign installation). Sufficient signage requires three total signs, totaling \$570.

The stated purpose of **Bill 25-111** is to *officially* designate the public alley system within Square 4546, bounded by 17th Street, N.E., E Street, N.E., 18th Street, N.E. and D Street, N.E. as *Rev. Lloyd N. Young Court NE*. For visualization purposes, I have attached to this testimony a copy of the plat of the designated

alley system. DDOT notes that in addition to new signage, this newly designated alley system will require new poles. In fiscal terms, the cost of each installed pole is approximately \$270. Sufficient poles and signage requires four total poles and four total signs, totaling \$1,840.

DDOT can absorb the costs of these signs and poles within its current budget and does not foresee any operational impact that these official and symbolic namings would have on the District's transportation network. Therefore, the Administration has no objection to these street and alley namings. DDOT stands ready to assist the Council and all other stakeholders with any ceremonial unveiling activities that may materialize as a result of these bills being passed.

This concludes my testimony. Thank you for allowing me the opportunity to testify before you today. I am available to answer any questions that you may have.

Background

Rev. Lloyd Young was a pastor at Greater Mount Pisgah Baptist Church on Capitol Hill for twenty-seven years before retiring in 1957. Rev. Young served with the United States Army in World War I and spent years serving the District's Rosedale and Kingman Park communities. Rev. Young died of pneumonia in 1980.

The bill officially designates all segments of the alley system within the block¹ bounded by 17th Street, N.E., D Street, N.E., 18th Street, N.E., and E Street, N.E. as Rev. Lloyd Young Court.

Financial Plan Impact

Funds are sufficient in the fiscal year 2023 through fiscal year 2026 budget and financial plan to implement the bill. The District Department of Transportation (DDOT) will fabricate and install four signs, including poles, at each of the alley system's entrances to officially designate the alley as Rev. Lloyd Young Court. The signs and poles will cost \$1,840 and DDOT can absorb the cost within its
