The District of Columbia Public Schools ("DCPS") will purchase an online, Reading and Math Diagnostic Assessment and Instruction system that provides real-time information to teachers and allows for adjustments in teaching and learning as well as aggregated data at the district level in specified formats. The contractor will be providing access to the i-Ready® platform to K-8th grades DCPS students, school personnel, and designated Central Services personnel. Platform access includes the ability to administer i-Ready® Reading and i-Ready® Math assessments, analyze assessment data using reporting features, respond to student learning needs by implementing i-Ready Instruction in both Reading and Math, and deliver student intervention instruction using i-Ready Math Teacher Toolbox, as well as a suite of resources, supports, and services.

(D) The selection process, including the number of offerors, the evaluation criteria, and the evaluation results, including price, technical or quality, and past performance components:

This procurement is exempt from competition in accordance with D.C. Official Code 2-354.13 (4,8), Section 413, 27 DCMR, Section 1703; number (4) Copyrighted or patented materials, including technical pamphlets, published books, maps, and testing or instructional materials; provided, that the materials are purchased directly from the owner of the copyright or patent; and (8) Maintenance and support of existing software and technology to the extent that the creator of the intellectual property is still protected and is the only source of the maintenance and support of the existing software and technology.

(F) The background and qualifications of the proposed contractor, including its organization, financial stability, personnel, and performance on past or current government or private sector contracts with requirements similar to those of the proposed contract:

For 50 years Curriculum Associates, LLC has been united around one common purpose – to make classrooms better places for teachers and students. Curriculum Associates assessment and instruction programs are backed by the industry's most practical and applicable research. Every program they provide starts with an extensive research base, and they then engage in a constant cycle of research, review, and improvement. The result is a suite of programs proven to help DCPS students succeed. Curriculum Associates, in partnership with the Educational Research Institute of America (ERIA), collected data across the country to study the relationship between the i-Ready

Diagnostic and leading national and state assessments for both English Language Arts (ELA) and Mathematics. Correlations between i-Ready and consortium and state assessments consistently exceed established benchmarks in education. 3 According to Dunn and Bradstreet Comprehensive Report, the Contractor is financially sound and has met all of its business obligations and there is no record of open suit(s), lien(s) or judgement(s).

(G) The period of performance associated with the proposed change, including date as of which the proposed change is to be made effective:

On September 1, 2022, contract modification no. 1 exercised partial option period one, in the amount of \$996,253.55, to prevent service lapse during the Council summer recess.

DCPS proposes Modification No. 2, to exercise the full option period, through August 31, 2023, for the full option period value of \$1,182,999.55, upon obtaining approval from the Council of the District of Columbia.

(H) The value of any work or services performed pursuant to a proposed change for which the Council has not provided approval, disaggregated by each proposed change if more than one proposed change has been aggregated for Council review:

On September 1, 2022, contract modification no. 1 exercised partial option period one, in the amount of \$996,253.55

Proposed modification no. 2 will be issued upon approval by the Council of the District of Columbia and increase the option period value to \$1,182,999.55.

(I) The aggregate dollar value of the proposed changes as compared with the amount of the contract as awarded:

The partial option period was awarded in the amount of \$996,253.55.

The proposed change through Modification No. 2 will increase that value by \$186,746.00 to \$1,182,999.55.

(J) The date on which the contracting officer was notified of the proposed change:

September 1, 2022

(K) The reason why the proposed change was sent to Council for approval after it is intended to take effect:

The option period was set to begin during Council summer recess. The agency did not have sufficient time to prepare the Council package, and receive timely passive approval from the Council of the District of Columbia, before its recess beginning in July 2022.

(L) The reason for the proposed change:

The District has a continuing need for a K-8 English Language Arts and Math Diagnostic Assessments Platform.

(M) The legal, regulatory, or contractual authority for the proposed change:

The proposed option exercise is authorized in accordance with 27 DCMR 36.

(N) A summary of the subcontracting plan required under section 2346 of the Small, Local, and Disadvantaged Business Enterprise Development and Assistance Act of 2005, as amended, D.C. Official Code § 2-218.01 et seq. A waiver of DC Code 2-218.46 Subcontracting Requirement was granted by the Department of Small and Local Business Development on May 4, 2022.

Performance will be measured quarterly and in accordance with the deliverables set forth in Section F.3 of the contract for period September 1, 2022 through August 31, 2023. The Contract Administrator will monitor the contract to ensure deliverables are met by due dates to ensure DCPS meet the needs of students.
