Explanation of difference from base period (if applicable): The base period amount was for three months, three days. The option period one is for one full year.

(C) The goods or services to be provided, the methods of delivering goods or services, and any significant program changes reflected in the proposed contract:

The contractor shall provide to District of Columbia Public Schools (DCPS) a spectrum of temporary health care staffing support related to the COVID-19 crisis. The contractor will provide critical services and support to ensure continuity of operations, continued pandemic recovery, and ongoing learning for DCPS students.

The services will be provided to and managed by DCPS throughout all DCPS campuses serving students K-12 students, as well as Central Services. The key functions required are:

- Health and safety screening for building entry;
- Operating and managing the Health Isolation Room;
- Centralized contact tracing and documentation for the purpose of minimizing spread and reporting to local public health authorities;
- Providing technical assistance on COVID-19 policies, relevant protocols and District guidance related to COVID-19;
- Administering and observing specimen collection for symptomatic and asymptomatic testing when needed;
- Communicating directly with families;
- Other health related duties as deemed necessary by the school related to COVID-19 and agreed upon by the School Leader and RN Supervisor; and
- Asymptomatic testing coordination.
- (D) The selection process, including the number of offerors, the evaluation criteria, and the evaluation results, including price, technical or quality, and past performance components:

On June 16, 2022, the District of Columbia Public Schools (DCPS), Office of Contracts and Acquisitions, issued Invitation for Bids (IFB) No. GAGA-2022-I-0142 in the open market, with a 35% certified business enterprise subcontracting requirement. Four bidders responded by the closing date of June 22, 2022. The contracting officer awarded the contract on June 27, 2022 to Maxim as the lowest-priced, responsive and responsible bidder.

(E) A description of any bid protest related to the award of the contract, including whether the protest was resolved through litigation, withdrawal of the protest by the protestor, or voluntary corrective action by the District. Include the identity of the protestor, the grounds alleged in the protest, and any deficiencies identified by the District as a result of the protest:

(F) The background and qualifications of the proposed contractor, including its organization, financial stability, personnel, and performance on past or current government or private sector contracts with requirements similar to those of the proposed contract:

Maxim is currently providing services to the satisfaction of DCPS under the current contract, which expires on September 30, 2023. Maxim was established in 1988, in response to a national nursing shortage to focus on the recruitment and staffing of quality healthcare professionals for a variety of healthcare organizations. Maxim provides services to more than 6,500 clients nationwide, including state, local and federal government agencies and departments, hospitals, correctional

facilities, schools, and skilled nursing facilities. Maxim employs more than 27,000 healthcare professionals across a variety of modalities and specialties, enabling DCPS to access the necessary personnel resources to deliver services for its educational programs. Maxim currently partners with several of the largest public-school districts in the US, including Los Angeles Unified School District (CA), Clark County School District (NV), Houston Independent School District (TX), Hillsborough County Public Schools (FL), Fairfax County Public Schools (VA), Gwinnett County Public Schools (GA) and Wake County Public Schools (NC).

Maxim has demonstrated through past performance that their organization has the history, personnel, and organizational and technical experience required to meet successfully the contract requirements. Likewise, Maxim maintains the financial resources, accounting, and operational controls to fulfill DCPS's requirements. Maxim has been deemed responsible in accordance with DCPS's standards for responsibility.

#### (J) The date on which the contracting officer was notified of the proposed change:

The contracting officer was notified of the need for the services in May 2022.

### (K) The reason why the proposed change was sent to Council for approval after it is intended to take effect:

There were multiple factors resulting in the awarding of the contract actions prior to submission to the Council. The main factor was that DCPS experienced increased rates of vacancies and turnovers in key staff, including the chief contracting officer position. This factor, along with the decentralized administrative structure of DCPS's contracting function, resulted in a failure to request and obtain Council approval before the contract actions were implemented. DCPS regrets this failure and is working to update and improve its processes and procedures and determine appropriate administrative actions to be taken in response to the failure.

#### (L) The reason for the proposed change:

The contracting officer awarded the initial contract and continued with the exercise of option year one so that the contractor could provide to DCPS a spectrum of temporary health care staffing support related to the COVID-19 crisis. The services were necessary for all DCPS campuses serving students K-12 students, as well as Central Services.
