I. BACKGROUND AND NEED

On June 7, 2023, Proposed Resolution 25-262, the "Commission on the Arts and Humanities Cecily Habimana Confirmation Resolution of 2023," was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 25-262 would confirm the Mayor's nomination of Ms. Cecily Habimana for appointment as a member of the Commission on the Arts and Humanities for the remainder of an unexpired three-year term to end June 30, 2025. Ms. Habimana is replacing Mary Ann Miller on the Commission.

Ms. Habimana is a Ward 5 resident. She received her Bachelor of Business Administration degree from Howard University, and a Master of Business Administration from The George Washington University School of Business. Currently, she serves as Chief Executive Officer/Owner of Sew Creative Lounge. Prior to starting Sew Creative, she worked for Simply Cecily as a fashion designer and McNeil Creative Enterprises as Creative Development Advisor.

Ms. Habimana also has served as a member of several boards included the Nsaa Dance Ensemble Advisory Board from 2005 to 2010, the Hunter Dance Theatre Advisory Board from 2007 to 2010, and the Atlas Performing Arts Center Board of the Board of Directors from 2012 to 2014.

The Commission on the Arts and Humanities (Commission) was established by the Commission on the Arts and Humanities Act, effective October 21, 1975 (D.C. Law 1-22; D.C. Official Code § 39-201 *et seq.*). The Commission is now an independent agency within the District government¹ and is designated by the National Endowment for the Arts as the state arts agency for the District of Columbia. Its role is to evaluate and initiate action on matters relating to the arts and humanities and to encourage programs and the development of programs that promote progress in the arts and humanities.²

The Commission consists of 14 members appointed by the Mayor for three-year term, with the advice and consent of the Council.³ The Commission is tasked with appointing an Executive Director who serves as the chief administrative officer of the Commission.⁴ In addition, the mission of the Commission is to provide grants, programs, and educational activities that encourage diverse artistic expressions and learning opportunities so that all District of Columbia residents and visitors can experience the District's rich arts and humanities community.⁵

Members of the Commission must be District residents and must have displayed an interest or an ability in the arts and humanities or must be active in the furtherance of the arts or humanities.⁶ Moreover, the Mayor has to give due consideration to recommendations made by the arts and humanities community, and has to ensure that there is reasonable representation of all the wards in the District when considering appointments to the Commission.⁷ Further, no employee of the District government can serve as a member of the Commission.⁸

In the Fiscal Year 2020 Budget Support Act of 2019,⁹ the Council approved additional requirements for individuals to be eligible to serve on the Commission. By July 1, 2019, six of the 18 members appointed to the Commission are required to meet the following requirements: (1) two members with specific interest, ability, or experience in the humanities; (2) two members with specific interest, ability, or experience in arts or humanities education; and (3) two members with specific interest, ability, or experience in theatre and performing arts.¹⁰ By July 1, 2020, four

of the 18 members appointed to the Commission are required to meet the following requirements: (1) two members with specific interest, ability, or experience in public art; and (2) two members with specific experience in arts or humanities organizational administration or governance.¹¹

An updated membership listing will be included once received from the Mayor's Office of Talent and Appointments (MOTA)

If appointed, Ms. Habimana plans to assist the Commission in further fostering artistic entrepreneurship by expanding outreach, offering additional resources and support which can include but are not limited to workshops and seminars, mentorship programs, access to business resources, and incubator spaces. Also, she will work to see that the Commission promotes the arts in every neighborhood since the arts play a significant role in the development of the District's vitality, image, and economic growth. She also will focus her attention and time to grant-making, cultural events, and building the creative economy; and will advocate for increased funding for the Commission. Further, Ms. Habimana's past service as a member of the Board of Directors for the Youth Orchestra of America and the Washington Ballet has strengthened her ability to serve on the Commission.

Ms. Habimana meets the requirements to serve as a member of the Commission pursuant to D.C. Official Code § 39-203(a-1)(2)(C) as she has a specific interest, ability, and experience in theatre and performing arts. The Committee believes Ms. Habimana's involvement in the District arts community attests to her ability to serve on the Commission. The Committee recommends adoption of PR 25-262.

The Committee received no testimony or comments in opposition to Ms. Habimana's reappointment.

Members of the Commission on the Arts and Humanities are appointed pursuant to section 4 of the Commission on the Arts and Humanities Act, effective October 21, 1975 (D.C. Law 1-22; D.C. Official Code § 39-203).

PR 25-262 will have no fiscal impact on the District of Columbia budget or financial plan. Pursuant to D.C. Official Code § 39-203(e), members of the Commission on the Arts and Humanities do not receive compensation.

My name is Cecily Habimana, co-owner of Sew Creative Lounge.

Before I get started, I would like to thank the Committee and for hosting this hearing and the Mayor for my nomination. I moved to Washington DC in 2000 to attend Howard University, where I received my BA in Business Management. I then earned my MBA with a concentration in nonprofit management from George Washington University in 2009. While at Howard, I wrote my first grant to the DC Commission on the Arts and Humanities to support a dance company that I performed with back in college. During my career, I've worked with a number of arts organizations throughout the DMV including the Dance Institute of Washington, the Atlas Performing Arts Center and the Clarice Smith Performing Arts Center. While at these organizations, I held various positions in development and managed relationships with institutional donors including the DC Commission on the Arts and Humanities.

Currently I run my company Sew Creative Lounge, located right outside of DC in Mount Rainier, Maryland. We are the culture keepers of sewing and quilting with a mission of teaching the world to sew one stitch at a time. I started this company after teaching pop up sewing classes at the Anacostia Arts Center from 2014-2016. I have been featured in several publications and blogs including The Washington Post, Washington Express, American Express website and Chicago Tribune. I have also appeared on Fox 5 News, NPR and WAMU 88.5 to name a few. I am also the recipient of the 6 Figure Success Award and Circle of 7 Award from Traffic, Sales and Profit Mastermind.

Through my experiences as a fundraiser for the arts, I grew to understand how important these funds are to artists and arts organizations throughout Washington, DC. Many of them would not be around if the funds were not available. I'm an artist. My mother is an artist. She taught art in the Chicago Public Schools for 30 years. I grew up surrounded by art. But I have learned that the importance of art is not just about the art itself. It's about being creative in all aspects of life. Creativity is what we do on a day-to-day basis. It's not just limited to dancing, acting or drawing but it's also linked to things as simple as how you want to plant flowers in your garden or adding a few extra spices to a recipe. Creativity **allows us to view and solve problems more openly and with innovation**. It opens our minds to the possibility. The arts also build confidence and help us **feel ready for life's experiences**.

I think my experience as an entrepreneur, artist and fundraiser would add a continued perspective to the board. It's important for the Commission to have someone who is an artist, who has been a grantee both as an individual and a representative of an arts organization and who understands the business of the arts.

My vision for the Commission is to continue to stay relevant. The need for artists has drastically changed in the past two years. We are just now getting out of the pandemic. A lot of artists didn't make it through that time. I would love to spearhead an initiative to re-engage artists and get more of them working and offering services in Washington, DC.

The DC Commission on the Arts and Humanities recognizes the importance of empowering artists and creative professionals to develop sustainable careers and businesses. As

It's important for the board to have someone who is an artist, who has been a grantee both as an individual and a representative of an arts organization and understands the business of the arts.

My vision for the board is to continue to stay relevant. The need for artists has drastically changed in the past two years. We are just now getting out of the pandemic. A lot of artists didn't make it through that time. I would love to spearhead an initiative to re-engage artists and get more of them working and offering services in Washington, DC.

The DC Commission on the Arts and Humanities recognizes the importance of empowering artists and creative professionals to develop sustainable careers and businesses. As the community member to the Commission, I would like to help DCAAH further foster artistic entrepreneurship by offering additional resources and support through workshops and seminars, mentorship programs, access to business resources and incubator spaces.
