I. BACKGROUND AND NEED

On June 7, 2023, Proposed Resolution 25-263, the "Commission on the Arts and Humanities Chase Maggiano Confirmation Resolution of 2023," was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 25-263 would confirm the Mayor's nomination of Mr. Chase Maggiano for appointment as a member of the Commission on the Arts and Humanities with experience in arts and humanities organizational administration or governance for a three-year term to end June 30, 2025. Mr. Maggiano is replacing Quanice Floyd on the Commission.

Mr. Maggiano is a Ward 3 resident. He received his Bachelor of Arts degree from The George Washington University. Currently, he serves as Owner and Luthier of Washington Fine Bows, which provides service and sales of fine bows of the violin family for professional musicians spanning the East coast. Prior to starting Washington Fine Bows, he worked for Potter Violins as the manager in charge of sales, operations and marketing where he managed the day-to-day

operations of the \$5M fine instrument business. Mr. Maggiano also has served as Executive Director of two noted District of Columbia singing ensembles – the Gay Men's Chorus of Washington and the Washington Chorus. He is board chair of Sound Impact and an advisory board member of the Coalition for African Americans in the Performing Arts.

The Commission on the Arts and Humanities (Commission) was established by the Commission on the Arts and Humanities Act, effective October 21, 1975 (D.C. Law 1-22; D.C. Official Code § 39-201 *et seq*.). The Commission is now an independent agency within the District government¹ and is designated by the National Endowment for the Arts as the state arts agency for the District of Columbia. Its role is to evaluate and initiate action on matters relating to the arts and humanities and to encourage programs and the development of programs that promote progress in the arts and humanities.²

The Commission consists of 14 members appointed by the Mayor for three-year term, with the advice and consent of the Council.³ The Commission is tasked with appointing an Executive Director who serves as the chief administrative officer of the Commission.⁴ In addition, the mission of the Commission is to provide grants, programs, and educational activities that encourage diverse artistic expressions and learning opportunities so that all District of Columbia residents and visitors can experience the District's rich arts and humanities community.⁵

Members of the Commission must be District residents and must have displayed an interest or an ability in the arts and humanities or must be active in the furtherance of the arts or humanities.⁶ Moreover, the Mayor has to give due consideration to recommendations made by the arts and humanities community, and has to ensure that there is reasonable representation of all the wards in the District when considering appointments to the Commission.⁷ Further, no employee of the District government can serve as a member of the Commission.⁸

In the Fiscal Year 2020 Budget Support Act of 2019,⁹ the Council approved additional requirements for individuals to be eligible to serve on the Commission. By July 1, 2019, six of the 18 members appointed to the Commission are required to meet the following requirements: (1) two members with specific interest, ability, or experience in the humanities; (2) two members with specific interest, ability, or experience in arts or humanities education; and (3) two members

with specific interest, ability, or experience in theatre and performing arts.¹⁰ By July 1, 2020, four of the 18 members appointed to the Commission are required to meet the following requirements: (1) two members with specific interest, ability, or experience in public art; and (2) two members with specific experience in arts or humanities organizational administration or governance.¹¹

An updated membership listing will be included once received from the Mayor's Office of Talent and Appointments (MOTA)

If appointed, Mr. Maggiano plans to assist the Commission in further strengthening the District's arts community by leveraging the Commission's resources. Also, he will work to see that the Commission promotes the arts in every neighborhood since the arts play a significant role in the development of the District's vitality, image, and economic growth. He also will focus his attention and time to grant-making, cultural events, and building the creative economy; and will advocate for increased funding for the Commission. Further, Mr. Maggiano's past service as a leader, and administrative head, of two large District arts organizations will serve the Commission well.

Mr. Maggiano meets the requirements to serve as a member of the Commission pursuant to D.C. Official Code § 39-203(a-1)(2)(C) as he has a specific interest, ability, and experience in theatre and performing arts. The Committee believes Mr. Maggiano's years of involvement in the arts attests to his ability to serve on the Commission. The Committee recommends adoption of PR 25-263.

Mr. Maggiano spent the first part of his professional life as a non-profit arts executive serving local organizations, including staff recruitment/management, artistic production, operational efficiency, financial oversight, relationship-building, and fundraising. From 2016 to 2018, he served as Executive Director of the Washington Chorus, overseeing the Grammy Award-winning company, including budget creation and fiscal management in excess of \$1MM, oversight of artistic programming and production for 15-20 mainstage events per season, executing artist contracts, leading fundraising, overseeing staff, and managing day-to-day operations. Immediately prior to this role, Mr. Maggiano served as Executive Director of the Gay Men's Chorus, where he led its role as an international voice of social justice through the arts with global programming, a broad and inclusive vision, and 40-50 performance events per season.

A Ward 3 resident, Mr. Maggiano obtained a bachelor of arts from Georgetown University, and serves as a board member of Sound Impact, on the Advisory Board Member of Coalition for African Americans in the Performing Arts, and member of the Violin Society of America.

Testimony of Chase Maggiano

Before the Committee of the Whole Council of the District of Columbia The Honorable Phil Mendelson, Chairperson

My name is Chase Maggiano, and I am grateful to the member of the Committee for hearing my testimony, and to the Mayor for her continued support of the arts and my nomination to the DCCAH. The last time I provided testimony to the Council was in 2017 as part of a cohort of arts executives and artists advocating for increased funding for the DC Commission on the Arts and Humanities. Like so much of my time as an arts executive, artist, and arts supporter in Washington, I was glad to be just a small part of helping more art happen through that effort.

I grew up in Northern Virginia and went to college at George Washington University where I studied English and Music. I remained here after school, and I have had the privilege of working in various roles in Washington within arts management, as a professional violinist, and in the musical instrument industry.

My day job is not one that is common in Washington. I am an expert luthier, specializing in the repair and restoration of fine bows of the violin family. With this niche skillset focused on antique violin bows which are both collectible and tools used my musicians, I bring the identity of maker/creator to the DCCAH. My job allows me to serve professional musicians playing at the highest level, as well as students in youth programs such as the DC Youth Orchestra Program DCYOP. The Washington DC region is home to more unionized musicians than New York City, and I have been honored to play violin alongside and get to know the varied musicians in our region. The vibrance of DC arts is something that I get to see every day in my profession, albeit from a slightly different angle.

My experience in the DC arts community runs much deeper than my profession as a luthier. I have been fortunate to engage with the DC Commission on the Arts and Humanities previously as executive director of two different non-profits choral organizations – The Gay Men's Chorus of Washington, DC and The Washington Chorus. In applying for and receiving grants, I know firsthand the how impactful the DCCAH can be to sustain and grow the home-grown talents of DC's artists and institutions. I have also had the opportunity to serve as a grant panelist, which gave me insight into the dedicated team working to make more art happen in the District.

I'm a believer that the arts can paint a picture of the world as we want it to be, and then it's up to everyone else to make that world a reality. Without the vision and inspiration of artists, our path toward a more harmonious and equitable society is blurred. I have spent the better part of my professional life, and nearly all my personal life, in the arts in and around Washington, DC. As an intern with Washington Performing Arts nearly 15 years ago, I saw how arts education creates more empathic, curious, and well-rounded children. Working under the leadership of Jenny Bilfield, I learned the value and need for inclusive and accessible arts, particularly across the river, where I was proud to produce WPA's first Fall Arts Festival the THEARC. My experience in creating more access carries with me today in my role as board chair of the Virginia-based arts education non-profit Sound Impact.

As a former executive director of two large chorus here in Washington, I have seen adults find community they never had before through the arts. In organizing concert tours with the State Department in Ukraine and Cuba, I have witnessed the direct effect that arts and culture can have on human rights advancements. And I am sure we all have experienced that the arts and humanities



can simply make our lives more pleasing and enjoyable, and sometimes art for art's sake can be enough to make our city a more vibrant place to live and visit. I believe that our city can reflect all these things and I am excited to be a small part of this mission.

My passion for the arts community in Washington is perhaps best exemplified by the 20+ years I have spent creating and supporting the creation of arts in this city. Of the hundreds of ensembles I have performed with or managed as an arts manager, one experience that inspires me most was overseeing the creation of the city's first LGBTQ youth chorus, the GenOUT chorus, under the banner of the Gay Men's Chorus of Washington. I am honored to have been a part of creating a community and a voice through music for vulnerable youth eight years ago, and that ensemble is still alive and strong today, now giving their own full concerts.

I desire to serve the DCCAH because I feel that it is my time to give back to a city that has given me so much. In being mentored by artistic leaders and peers in this city, I have come to know the values of equity, of high-level artistry and of community connectivity through the arts. Having led two different large arts organizations in this city, I know how art happens and I understand the constraints and opportunities of local artists and community organizations. I am knowledgeable about organizational finances, mission alignment, staffing constraints, and the community needs of our city. I hope to bring this experience to the DCCAH in supporting the broad landscape of arts organizations and artists in this city.

Washington has a rich history and strong fabric of artists who serve as the heartbeat of Washington, and it is this richness that deserves continued support. I hope that our city might find



ways to create and promote more arts events which attract visitors from neighboring regions. As a proud DC resident, I love that visitors often come to our city to use their voice in protest for a better tomorrow, or to look back at the history of the founding of our nation. I also love the idea that we can have a vibrant living conversation of art and culture which encourages visitors and local artists alike to connect and reflect on the world today.

As the world around us is changing, the DCCAH is also in a period of strategic and cultural change. I hope to meet the moment by being a voice on the committee who bridges the best of our recent past as a culturally innovative city while looking toward the future with a keen sense of what's possible. Anyone who knows me as an arts manager knows that I thrive in the dream space, but I also create in the space of reality. I believe a board should be allowed to dream, especially a board focused on arts and culture. I am confident that my experience and temperament can be harnessed for organizational thoughtfulness and reliable board governance to help the DCCAH encourage maximum participation in the arts and humanities in Washington.

In applying for and receiving grants, I know first-hand the how impactful the commission can be to sustain and grow the home-grown talents of DC's artists and institutions. I have also had the opportunity to serve as a grant panelist, which gave me insight into the dedicated team working to make more art happen in the District. I'm a believer that the arts have the ability to paint a picture of the world as we want it to be, and then it's up to us to make that world a reality. Without the vision and inspiration, our path toward a more harmonious society can't happen. I have spent the better part of my professional life, and nearly all of my personal life, in the arts in Washington, DC. As an

intern with Washington Performing Arts nearly 15 years ago, I saw how arts education creates more empathic, curious, and well-rounded children. As an executive director of two large chorus here in Washington, I have seen adults find community they never had before through the arts. In organizing concert tours with the State Department, I have witnessed the effect that arts and culture can have on human rights advancements. And I am sure we all have experienced that the arts and humanities can simply make our lives more pleasing and enjoyable, and sometimes art for art sake can be enough to make our city a better place to live. I believe that our city can reflect all of these things and I am excited to be a small part of this mission.

While I do not know all the operational aspects of the DC Commission on the Arts and Humanities, I might offer two points of reflection for future growth. I believe that our city can become even more of a destination for arts and culture, through large scale events and exhibitions that promote connections between DC artists and artists from other places. I also hope to see continued improvements in equitable grantmaking practices. Not every organization or artist is equally equipped to complete grant requirements, or even learn about grant possibilities. There is a growing movement to change the lens through which grantmakers evaluate organizations, and I hope DC can be a leader in that movement.

In my written testimony, I have provided more details about my background and my inspiration for serving the DC Commission on the Arts and Humanities.
