I. BACKGROUND AND NEED

On June 7, 2023, Proposed Resolution 25-264, the "Commission on the Arts and Humanities Carla Sims Confirmation Resolution of 2023," was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 25-264 would confirm the Mayor's nomination of Ms. Carla Sims for reappointment as a member of the Commission on the Arts and Humanities for a three-year term to end June 30, 2026.

Ms. Sims is a Ward 6 resident. She received her Bachelor of Arts degree from Hampton University and a Certificate of Special Studies in Administration and Management from the Extension School at Harvard University. Currently, she owns and operates FYIMG, Inc., an entertainment and production company. Ms. Sims also has served as a Major in the U.S. Army Reserves and worked in the Pentagon as the Special Assistant for External Affairs to the Undersecretary of Defense for Personnel and Readiness. In this position, she facilitated national

speaking and outreach opportunities to promote new ways for communities, institutions, and organizations to view the Department of Defense. Ms. Sims was a founding board member of Howard Theater Restoration and sat on the board of Duke Ellington School of the Arts in Washington, DC.

The Commission on the Arts and Humanities (Commission) was established by the Commission on the Arts and Humanities Act, effective October 21, 1975 (D.C. Law 1-22; D.C. Official Code § 39-201 et seq.). The Commission is now an independent agency within the District government and is designated by the National Endowment for the Arts as the state arts agency for the District of Columbia. Its role is to evaluate and initiate action on matters relating to the arts and humanities and to encourage programs and the development of programs that promote progress in the arts and humanities.²

The Commission consists of 14 members appointed by the Mayor for three-year term, with the advice and consent of the Council.³ The Commission is tasked with appointing an Executive Director who serves as the chief administrative officer of the Commission.⁴ In addition, the mission of the Commission is to provide grants, programs, and educational activities that encourage diverse artistic expressions and learning opportunities so that all District of Columbia residents and visitors can experience the District's rich arts and humanities community.⁵

Members of the Commission must be District residents and must have displayed an interest or an ability in the arts and humanities or must be active in the furtherance of the arts or humanities.⁶ Moreover, the Mayor has to give due consideration to recommendations made by the arts and humanities community, and has to ensure that there is reasonable representation of all the wards in the District when considering appointments to the Commission.⁷ Further, no employee of the District government can serve as a member of the Commission.⁸

In the Fiscal Year 2020 Budget Support Act of 2019,⁹ the Council approved additional requirements for individuals to be eligible to serve on the Commission. By July 1, 2019, six of the 18 members appointed to the Commission are required to meet the following requirements: (1) two members with specific interest, ability, or experience in the humanities; (2) two members with specific interest, ability, or experience in arts or humanities education; and (3) two members

with specific interest, ability, or experience in theatre and performing arts. ¹⁰ By July 1, 2020, four of the 18 members appointed to the Commission are required to meet the following requirements: (1) two members with specific interest, ability, or experience in public art; and (2) two members with specific experience in arts or humanities organizational administration or governance. ¹¹

If reappointed, Ms. Sims plans to continue to assist the Commission in further strengthening the District's artistic community through active service. During her tenure, she actively served on the Public Arts Committee and the Finance Committee and been a reviewer on numerous grant panels. Ms. Sims notes that she will continue to dedicate herself wholeheartedly to nurturing the District's vibrant cultural ecosystem, enriching the community through the transformative power of art, and striving to ensure that art remains accessible, diverse, and significant. She expressed pride in the notable strides the Commission has made in the three years she has participated, including expanded outreach and engagement with communities that had been previously underrepresented in the city's cultural tapestry.

Ms. Sims meets the requirements to serve as a member of the Commission pursuant to D.C. Official Code § 39-203(a-1)(2)(C) as he has a specific interest, ability, and experience in theatre and performing arts. The Committee believes Ms. Sims years of involvement in the arts attests to her ability to serve on the Commission. The Committee recommends adoption of PR 25-264.

Carla Sims is a three-time Grammy Award-winning producer, strategic communications expert with over 30 years of results-oriented experience in marketing, communications, project management, media-relations, branding, and event, film and television production. Her experience developing integrated communications campaigns for entertainment, corporate, nonprofit and government clients gives her a unique perspective on building and managing the brands of products, institutions and cultural icons.
