## I. BACKGROUND AND NEED

On June 7, 2023, Proposed Resolution 25-266, the "Commission on the Arts and Humanities Hector Torres Confirmation Resolution of 2023," was introduced by Chairman Phil Mendelson at the request of the Mayor. PR 25-266 would confirm the Mayor's nomination of Mr. Hector Torres for reappointment as a member of the Commission on the Arts and Humanities for a three-year term to end June 30, 2026.

Mr. Torres is a Ward 6 resident. He received his Bachelor of Science degree in Secondary Art Education from St. John's University. He is a Principal at Absolute Hospitality, a selfemployed hospitality consultant, and a freelance artist-painter. Mr. Torres had a long and successful 49-year career in the hospitality industry where he served as the Vice President of Beacon Hotel & Corporate Quarters, and at Capital Hotels and Suites. In his retirement, Mr. Torres spends his time making people happy not only through the hospitality industry, but through his original passion of art.

The Commission on the Arts and Humanities (Commission) was established by the Commission on the Arts and Humanities Act, effective October 21, 1975 (D.C. Law 1-22; D.C. Official Code § 39-201 *et seq.*). The Commission is now an independent agency within the District government<sup>1</sup> and is designated by the National Endowment for the Arts as the state arts agency for the District of Columbia. Its role is to evaluate and initiate action on matters relating to the arts and humanities and to encourage programs and the development of programs that promote progress in the arts and humanities.<sup>2</sup>

The Commission consists of 14 members appointed by the Mayor for three-year terms, with the advice and consent of the Council.<sup>3</sup> The Commission is tasked with appointing an Executive Director who serves as the chief administrative officer of the Commission.<sup>4</sup> In addition, the mission of the Commission is to provide grants, programs, and educational activities that encourage diverse artistic expressions and learning opportunities so that all District of Columbia residents and visitors can experience the District's rich arts and humanities community.<sup>5</sup>

Members of the Commission must be District residents and must have displayed an interest or an ability in the arts and humanities or must be active in the furtherance of the arts or humanities.<sup>6</sup> Moreover, the Mayor has to give due consideration to recommendations made by the arts and humanities community, and has to ensure that there is reasonable representation of all the wards in the District when considering appointments to the Commission.<sup>7</sup> Further, no employee of the District government can serve as a member of the Commission.<sup>8</sup>

In the Fiscal Year 2020 Budget Support Act of 2019,<sup>9</sup> the Council approved additional requirements for individuals to be eligible to serve on the Commission. By July 1, 2019, six of the 18 members appointed to the Commission are required to meet the following requirements: (1) two members with specific interest, ability, or experience in the humanities; (2) two members with specific interest, ability, or experience in arts or humanities education; and (3) two members with specific interest, ability, or experience in theatre and performing arts.<sup>10</sup> By July 1, 2020, four of the 18 members appointed to the Commission are required to meet the following requirements:

(1) two members with specific interest, ability, or experience in public art; and (2) two members with specific experience in arts or humanities organizational administration or governance.<sup>11</sup>

Mr. Torres has found the experience as commissioner as challenging and gratifying at multiple levels. He has been proactive in various committees particularly the Grants Committee, Executive Committee and Education Committee, that oversee the funding and program offers that are driven by established principles of diversity, equity and inclusion. Mr. Torres has been gratified to see how the Commission has further evolved in its support of communities of color, with intentionality, while also supporting the District's world class arts institutions and encouraging inclusive operating practices. He notes that in recent years the Commission has significantly grown its reach and supported nascent arts practitioners and artistic endeavors, and that without the Commission's support these artists would not have been able to have their voices heard, seen, or appreciated.

Mr. Torres meets the requirements to continue to serve as a member of the Commission pursuant to D.C. Official Code § 39-203(a-1)(2)(C) as he has a specific interest, ability, and experience in theatre and performing arts. The Committee believes Mr. Torres years of involvement in the arts attests to her ability to serve on the Commission. The Committee recommends adoption of PR 25-266.

## About the Artists Work:

Working in a range of styles, mediums and imagery, representing works both non-figurative and abstract all an attempt to create works that represent diverse ways to express and respond to a wide rate of interests. Works on paper or canvas represent an exploration of color, exploiting the contrasts and harmonies created by color, and the emotions and memories they evoke. The use of color to define and create form, even the absence of such.

Often the works take on a level of experimentation in the form of assemblage by mixing and experimenting with textures, found objects and ephemera with occasional journeys to capture fantasy, faith, the familiar and sentimentality.
