I. BACKGROUND AND NEED

Proposed Resolution 25-282, the "Board of Trustees of the University of the District of Columbia Warner Session Confirmation Resolution of 2023," was introduced by Chairman Mendelson at the request of the Mayor on June 15, 2023 and referred to the Committee of the Whole. The purpose of PR 25-282 is to confirm the Mayor's nomination of Warner Session for appointment to the Board of Trustees of the University of the District of Columbia (Board) for a five-year term to end May 15, 2028. He would fill the seat previously held by Dr. Elaine Crider.

The University of the District of Columbia (UDC) is both a Historically Black College and University (HBCU) and an urban land-grant institution. Formed in 1975 from the merger of the District of Columbia Teachers' College, the Washington Technical Institute, and Federal City College, UDC serves as the District's only public university.¹ UDC's mission is to provide an

affordable, post-secondary education to District residents and to "prepare students for immediate entry into the workforce, the next level of education, specialized employment opportunities or lifelong learning."²

The Board of Trustees of the University of the District of Columbia was established by the U.S. Congress as a body of the District of Columbia government in 1974.³ The Board has the authority to independently issue regulations governing the University, own and manage the property of the University, and represent the University in legal proceedings. The Board is also responsible for hiring the President of the University System.

Trustees are charged with establishing and ensuring accreditation of each component of the University System. This includes a liberal arts component, a vocational and technical component, and a school of law. The Trustees approve all programs and majors and set academic policies, such as degree requirements and tuition. In addition, Trustees are responsible for setting the University's budget in conjunction with the Mayor and City Council.

The Board is comprised of fifteen members.⁴ Of the fifteen, eleven are appointed by the Mayor with the advice and consent of the Council, three are alumni from either the University or one of its predecessor institutions, and one is a full-time student elected by the UDC student body.⁵ Each Trustee, except for the student trustee, serves a five year term, and each non-student Trustee may serve two consecutive full terms.⁶ The following tables depict the current make-up of the UDC Board of Trustees:

Mr. Session earned a Juris Doctor from Georgetown University Law Center in 1982 and a Bachelor of Arts from Stanford University in 1977. He has been a District resident for over 40 years and is currently a Ward 1 resident. He has been the Principal/Owner of Session Law Firm, P.C. since 1991. He has achieved significant success building and growing a professional consulting/legal practice while weathering challenging economic, regulatory, environmental, compliance, and global security situations. Mr. Session has held roles as a staff attorney in local and federal governments including positions with congressional committees.

As a Board Member of the Metropolitan Washington Airports Authority and as an attorney for companies and organizations representing multiple industry sectors including aviation/airports, health care, real estate and pharmaceutical, Mr. Session has contributed his expertise and added value to legal and policy matters, legislative advocacy, risk mitigation and oversight for major projects. He has been honored for significant professional and personal leadership contributions to African American and underserved communities.

The University has made great strides over the last decade, despite the COVID-19 pandemic; however, more needs to be done. Moving forward, and during Mr. Session's time on the Board, the Committee will be paying particular attention to the two following issues.

Enrollment: Over the past decade, UDC has struggled to increase enrollment. The struggle was exacerbated by the COVID-19 pandemic when the University saw another decline in enrollment. A key to a successful education system in the District is a thriving public university, and instrumental to having a thriving public university is its enrollment. Thus, as the District's only public institution of higher education, it is essential that UDC's enrollment not only remain steady, but also grow. Given this, the Committee has monitored the University's enrollment over

the years. A part of this monitoring involves not just watching UDC's overall enrollment, but also looking at the enrollment of UDC's four-year institution, Community College (UDC-CC), and law school. Since UDC-CC was formed in 2009, the Committee has focused on UDC's enrollment data. However, the University has made increasing enrollment a priority. For example, the University now automatically re-enrolls all Community College students, the University has recently on boarded a new Vice President of Enrollment Management, and the University will begin the initial implantation of its Customer Relationship Management (CRM). This tool is a set of integrated, data-driven software solutions that help manage, track, and store information. This will be critical in better understanding and managing enrollment data. The table below shows UDC's enrollment, broken down by undergraduate, graduate, law school, and community college, from academic year 2012-2013 through its most recent academic year, 2022-2023.

Private Fundraising: Beginning in fiscal year 2014, the Council has set aside funds for the University as part of a fundraising match. Originally as a means of supporting UDC's accreditation efforts, the Council set aside a million dollars in matching funds.⁷ For every dollar UDC raised in private donations, the District matched those donations dollar for dollar up to a maximum of a million dollars. A District match has continued since 2014. Although the original impetus for the match was to provide additional support for UDC's accreditation activities, secondary reasons for the match have been to incentivize the University to increase its private fundraising capability and to encourage the UDC Foundation to take a more active role in raising private funds. As discussed in Committee budget reports, UDC has to fight year after year for its subsidy, as well as for capital funds from the District government. The University should continue to increase its private fundraising, even though the Committee believes wholeheartedly that the District should support UDC financially.

Based on his commitment to the mission of the University, his educational leadership, and his dedication to improving equitable outcomes, the Committee recommends the appointment of Mr. Session to the Board of Trustees of the University of the District of Columbia. The Committee of the Whole recommends adoption of PR 25-282.

III. POSITION OF THE EXECUTIVE

Mr. Session is the Mayor's nominee for appointment to the Board of Trustees of the University of the District of Columbia.

IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 25-282.

V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on four Board of Trustees of the University of the District of Columbia nominations, including PR 25-282, on Wednesday, July 12, 2023. The testimony summarized below is from that hearing, pertaining to Mr. Session. Submitted copies of testimony are attached to this report.

Warner Session, *Appointee*, testified and answered questions from Chairman Mendelson regarding his background and experience as it pertains to the Board and his interest in serving on the Board. Mr. Session explained that he is particularly proud of being able to enhance the collaboration between UDC and the Airports Authority has UDC operates an aircraft maintenance training facility at one of the hangars at National Airport. He stated he will work to gain a deep

understanding of what UDC's challenges have been over the years and make best efforts to find creative and sustainable solutions, explore new policies to enhance student support services and academic programs to improve outcomes, and focus attention on infrastructure and facilities to make sure that they meet the highest standards.

VI. IMPACT OF EXISTING LAW

This confirmation is consistent with existing law. Pursuant to D.C. Official Code § 38-1202.01, the Board shall be comprised of fifteen members – of whom eleven members are appointed by the Mayor and confirmed by the Council. Of the eleven members, seven must be District residents at the time of their confirmation. Additionally, each member, except for the student trustee, may serve three, five-year terms or a total of 15 consecutive years.⁸ Mr. Session is a Mayoral appointee, is a resident of the District, and is nominated for his first term.

VII. FISCAL IMPACT

PR 25-282 will have no fiscal impact on the District of Columbia budget or financial plan. Pursuant to D.C. Official Code § 38-1202.04, trustees receive no compensation for their service on the Board.⁹ However, each trustee is entitled to be reimbursed up to \$4,000 annually for any "actual and necessary expenses incurred while actually engaged in service as a Trustee."¹⁰ Such expenses are included as part of the University's annual budget.

VIII. SECTION-BY-SECTION ANALYSIS

- <u>Section 2</u> Confirms the appointment of Warner Session to the Board of Trustees of the University of the District of Columbia to serve a term of five years.¹¹
- <u>Section 3</u> Requires that a copy of the resolution, upon adoption, be transmitted to the nominee and to the Mayor.
- Section 4 Provides that PR 25-282 shall take effect immediately.

Thank you for this opportunity to appear before you today in support of my nomination to the Board of Trustees of the University of the District of Columbia (UDC). I am Warner Session, founder, and principal of Session Law Firm in the District of Columbia.

I want to first thank Mayor Muriel Bowser for this tremendous opportunity for public service. I am excited and eager to get started. I am absolutely confident that I will bring value, wisdom, and vision to the UDC Board.

My confidence stems from my over 40 years of active engagement in the political, public, and professional affairs of the District of Columbia. I came to Washington in 1979 to attend Georgetown University Law School. Upon graduation, I joined the staff of Ward 8 Councilmember Wilhelmina J. Rolark as a Staff Attorney. It was in Councilmember Rolark's Office that I first became embedded in District public policy matters and had the opportunity to work on important issues of the day, such as bail reform and public safety. After leaving the Council, I worked on Capitol Hill for a House Oversight Committee chaired by the Hon. Cardiss Collins (D-IL). In 1992, I left the Hill and formed Session Law Firm, where I have been for the last 31 years.

While building a law practice, I continued to be active in District of Columbia affairs as a member of the DC Bar and was appointed by Mayor Marion Barry to serve on the Human Rights Commission. I also worked closely with the Council and the Executive Office of the Mayor over many years on small and minority business issues, helping to shape legislation which we now know as the Certified Business Enterprise law to advance and promote the utilization of local District firms.

In 2011, I was appointed by Mayor Vince Gray to the Board of the Metropolitan Washington Airports Authority (MWAA - National and Dulles Airports) and reappointed by Mayor Muriel Bowser in 2017. During my 12 years on the MWAA Board, I served 4 years as Vice Chairman and 2 years as Chairman. That time was well-spent as I was able to substantially expand the number of DC-based businesses that were able to pursue opportunities at the Airports Authority.

I am particularly proud of being able to enhance the collaboration between UDC and the Airports Authority. UDC operates an aircraft maintenance training facility at one of the hangars at National Airport. It was through that collaboration that I came to know and work with President Ron Mason. I expect to build on the success of that program as a Trustee.

I will approach this assignment as a UDC Trustee the same way as I have with all new professional tasks that I have undertaken. I will begin with a proactive on-boarding process that would entail meeting with former and current Trustees, meeting with the new President, Dr. Maurice Edington, and members of his senior staff, and collecting information and intelligence on best practices in higher education and similarly situated institutions as UDC. I will work to gain a deep understanding of what UDC's challenges have been over the years and make best efforts to find creative and sustainable solutions. I will also explore new policies to enhance student support services and academic programs to improve outcomes. Further, I will focus attention on infrastructure and facilities to make sure that they meet the highest standards.

Finally, I will seek to leverage the considerable professional and civic resources that I now enjoy through by current participation in the DC Bar, Federal City Council, and other organizations such as the DC Statehood PAC, Thurgood Marshall Center Trust, and President Lincoln's Cottage.
