### I. BACKGROUND AND NEED

Proposed Resolution 25-284, the "Board of Trustees of the University of the District of Columbia Ken Grossinger Confirmation Resolution of 2023," was introduced by Chairman Mendelson at the request of the Mayor on June 15, 2023 and referred to the Committee of the Whole. The purpose of PR 25-284 is to confirm the Mayor's nomination of Ken Grossinger for reappointment to the Board of Trustees of the University of the District of Columbia (Board) for a five-year term to end May 15, 2028.

The University of the District of Columbia (UDC) is both a Historically Black College and University (HBCU) and an urban land-grant institution. Formed in 1975 from the merger of the District of Columbia Teachers' College, the Washington Technical Institute, and Federal City College, UDC serves as the District's only public university.<sup>1</sup> UDC's mission is to provide an

affordable, post-secondary education to District residents and to "prepare students for immediate entry into the workforce, the next level of education, specialized employment opportunities or lifelong learning."<sup>2</sup>

The Board of Trustees of the University of the District of Columbia was established by the U.S. Congress as a body of the District of Columbia government in 1974.<sup>3</sup> The Board has the authority to independently issue regulations governing the University, own and manage the property of the University, and represent the University in legal proceedings. The Board is also responsible for hiring the President of the University System.

Trustees are charged with establishing and ensuring accreditation of each component of the University System. This includes a liberal arts component, a vocational and technical component, and a school of law. The Trustees approve all programs and majors and set academic policies, such as degree requirements and tuition. In addition, Trustees are responsible for setting the University's budget in conjunction with the Mayor and City Council.

The Board is comprised of fifteen members.<sup>4</sup> Of the fifteen, eleven are appointed by the Mayor with the advice and consent of the Council, three are alumni from either the University or one of its predecessor institutions, and one is a full-time student elected by the UDC student body.<sup>5</sup> Each Trustee, except for the student trustee, serves a five year term, and each non-student Trustee may serve two consecutive full terms.<sup>6</sup> The following tables depict the current make-up of the UDC Board of Trustees:

Mr. Grossinger received his Bachelor of Science in Psychology and Philosophy from S.U.N.Y. Brockport and his Masters in Social Work from Columbia University. He is a Ward 1 resident. He is a principal at Democracy Partners (DP), a strategic consulting firm where he directs the Impact Philanthropy and Donor advising division. Mr. Grossinger works with institutional and individual donors and advocate organizations to maximize the strategic use of their resources to advance policy and program priorities. In addition to serving as a principal at DP, Mr. Grossinger is co-founder and Chair of the CrossCurrents Foundation and its sister affiliate in London, CrossCurrents-UK. The funding portfolios of both foundations focus on non-partisan civic engagement, civil liberties, human rights and the arts.

Mr. Grossinger is active and has served on several governing boards including the Alliance for Justice (Chair), Washington DC Housing Authority Board of Commissioners (formerly Vice Chair), the Environmental Grantmakers Association, and the Grantmakers in the Arts. He is also on the advisory board of the NY New School for Social Research Center for Art and Politics.

The University has made great strides over the last decade, despite the COVID-19 pandemic; however, more needs to be done. Moving forward, and during Mr. Grossinger's time on the Board, the Committee will be paying particular attention to the two following issues.

**Enrollment**: Over the past decade, UDC has struggled to increase enrollment. The struggle was exacerbated by the COVID-19 pandemic when the University saw another decline in enrollment. A key to a successful education system in the District is a thriving public university, and instrumental to having a thriving public university is its enrollment. Thus, as the District's only public institution of higher education, it is essential that UDC's enrollment not only remain steady, but also grow. Given this, the Committee has monitored the University's enrollment over

the years. A part of this monitoring involves not just watching UDC's overall enrollment, but also looking at the enrollment of UDC's four-year institution, Community College (UDC-CC), and law school. Since UDC-CC was formed in 2009, the Committee has focused on UDC's enrollment data. However, the University has made increasing enrollment a priority. For example, the University now automatically re-enrolls all Community College students, the University has recently on boarded a new Vice President of Enrollment Management, and the University will begin the initial implantation of its Customer Relationship Management (CRM). This tool is a set of integrated, data-driven software solutions that help manage, track, and store information. This will be critical in better understanding and managing enrollment data. The table below shows UDC's enrollment, broken down by undergraduate, graduate, law school, and community college, from academic year 2012-2013 through its most recent academic year, 2022-2023.

**Private Fundraising:** Beginning in fiscal year 2014, the Council has set aside funds for the University as part of a fundraising match. Originally as a means of supporting UDC's accreditation efforts, the Council set aside a million dollars in matching funds.<sup>7</sup> For every dollar UDC raised in private donations, the District matched those donations dollar for dollar up to a maximum of a million dollars. A District match has continued since 2014. Although the original impetus for the match was to provide additional support for UDC's accreditation activities, secondary reasons for the match have been to incentivize the University to increase its private fundraising capability and to encourage the UDC Foundation to take a more active role in raising private funds. As discussed in Committee budget reports, UDC has to fight year after year for its subsidy, as well as for capital funds from the District government. The University should continue to increase its private fundraising, even though the Committee believes wholeheartedly that the District should support UDC financially.

Based on his commitment to the mission of the University, his educational leadership, and his dedication to improving equitable outcomes, the Committee recommends the appointment of Mr. Grossinger to the Board of Trustees of the University of the District of Columbia. The Committee of the Whole recommends adoption of PR 25-284.

#### **II. LEGISLATIVE CHRONOLOGY**

June 15, 2023	PR 25-284, the "Board of Trustees of the University of the District of Columbia Ken Grossinger Confirmation Resolution of 2023" is introduced by Chairman Mendelson at the request of the Mayor.

### **III. POSITION OF THE EXECUTIVE**

Mr. Grossinger is the Mayor's nominee for appointment to the Board of Trustees of the University of the District of Columbia.

### IV. COMMENTS OF ADVISORY NEIGHBORHOOD COMMISSIONS

The Committee received no testimony or comments from any Advisory Neighborhood Commission on PR 25-284.

### V. SUMMARY OF TESTIMONY

The Committee of the Whole held a public roundtable on four Board of Trustees of the University of the District of Columbia nominations, including PR 25-284, on Wednesday, July 12, 2023. The testimony summarized below is from that hearing, pertaining to Mr. Grossinger. Submitted copies of testimony are attached to this report.

*Ken Grossinger*, *Appointee*, testified and answered questions from Chairman Mendelson regarding his background and experience as it pertains to the Board and his interest in serving on the Board. Mr. Grossinger explained since joining the UDC board, he has worked in numerous roles to advance the University's mission. Shortly after joining the board, he became Chair the Operations Committee, a role he served in for most of his first term. In this role, he instituted more

frequent reporting requirements in such areas as safety to better analyze and monitor performances and practices that are working or in need of change. He was also one of three Board members who served on the search committee to select the new President, Dr. Maurice Edington, who was unanimously approved by the Board. He looks forward to continuing in this work at the University.

#### VI. IMPACT OF EXISTING LAW

This confirmation is consistent with existing law. Pursuant to D.C. Official Code § 38-1202.01, the Board shall be comprised of fifteen members – of whom eleven members are appointed by the Mayor and confirmed by the Council. Of the eleven members, seven must be District residents at the time of their confirmation. Additionally, each member, except for the student trustee, may serve three, five-year terms or a total of 15 consecutive years.<sup>8</sup> Mr. Grossinger is a Mayoral appointee, is a resident of the District, and is nominated for his second term.

### VII. FISCAL IMPACT

PR 25-284 will have no fiscal impact on the District of Columbia budget or financial plan. Pursuant to D.C. Official Code § 38-1202.04, trustees receive no compensation for their service on the Board.<sup>9</sup> However, each trustee is entitled to be reimbursed up to \$4,000 annually for any "actual and necessary expenses incurred while actually engaged in service as a Trustee."<sup>10</sup> Such expenses are included as part of the University's annual budget.

### VIII. SECTION-BY-SECTION ANALYSIS

Section 1	States the short title of PR 25-284.

- <u>Section 2</u> Confirms the appointment of Ken Grossinger to the Board of Trustees of the University of the District of Columbia to serve a term of five years.<sup>11</sup>
- <u>Section 3</u> Requires that a copy of the resolution, upon adoption, be transmitted to the nominee and to the Mayor.
- Section 4 Provides that PR 25-284 shall take effect immediately.

Mayor Bowser, thank you for nominating me and giving me an opportunity to serve the District in such an important way.

Since joining the UDC board, I've worked in numerous roles to advance the University's mission. Shortly after joining the board, I became Chair the Operations Committee, a role I have served in for most of my first term. Along with carrying out other routine committee duties, I instituted more frequent reporting requirements in such areas as safety, so we can better analyze and monitor performances and practices that are working or in need of change. Like all universities and city agencies, I dove deeply into best protective practices to prevent the spread of Covid.

This past year, I gave up my role as Chair of the Operations committee to become the Chair of the Audit, Budget and Finance Committee, and a member of the board's Executive Committee. In addition, I was one of three UDC Board members who served on the search committee to select the new UDC president, Dr. Maurice Edington, who was unanimously approved by the Board.

I've also used my role on the Board of Trustees of the Hirshhorn Museum and Sculpture Garden to create and facilitate a new internship program for our art students. I arranged meetings with the Hirshhorn Director, Melissa Chui, her staff, and with then-President Mason and his staff to explore the feasibility of creating a pilot program whereby a UDC art student could work at the Hirshhorn with a paid internship, in the hope that this would create as pipeline for UDC's art students into the art market. I'm proud to report that it worked well, and that the Hirshhorn offered the first student a part-time job! Together with the university, they've launched an annual internship program for UDC art students which I hope will expand to include other students.

With the addition of Dr. Edington to our campus, UDC is positioned to move to the next level, with greater fundraising, student retention and graduation rates, and more. These are some of the demonstrable skill sets Dr. Edington brings with him, and I am looking forward to supporting his work and that of the University.

It's been my delight to serve out my first term on the UDC board.

Thank you, Mr. Chairperson for the opportunity to testify before the committee. I am happy to respond to your questions or those of other Councilmembers.
