

A RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend the Rules of Organization and Procedure for the Council of the District of Columbia, Council Period 26, Resolution of 2025 to eliminate the Committee on Business and Economic Development and transfer jurisdiction of its subject matter and agencies to \_\_\_\_\_; and to amend the Council Period 26 Appointment of Chairperson Pro Tempore, Committee Chairpersons, and Committee Membership Resolution of 2025 to appoint a President Pro Tempore, to no longer appoint a chairperson and membership of the Committee on Business and Economic Development, and to make membership changes to other Council committees.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Council Period 26 Rules of Organization and Procedure and Appointment of Committee Chairpersons and Membership Amendment Resolution of 2026”.

Sec. 2. The Rules of Organization and Procedure for the Council of the District of Columbia, Council Period 26, Resolution of 2025, effective January 2, 2025 (Res. 26-1; 72 DCR 1289), is amended as follows:

(a) The Table of Contents is amended by striking the phrase “232. COMMITTEE ON BUSINESS AND ECONOMIC DEVELOPMENT.” and inserting the phrase “232. COMMITTEE ON BUSINESS AND ECONOMIC DEVELOPMENT. [REPEALED].” in its place.

(b) Section 232 (Committee on Business and Economic Development) is amended to read as follows:

55 (a) Section 2 is amended by striking the phrase “Kenyan McDuffie” and inserting the
