To approve the multiyear extension of Contract No. CFOPD-17-C-009 with Paymentech LLC to continue to provide merchant processing services on behalf of the District of Columbia's Office of Finance and Treasury.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Contract No. CFOPD-17-C-009, Extension Approval and Payment Authorization Approval Resolution of 2026."

Sec. 2. (a) Pursuant to Section 451 of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51) and section 202 of the District of Columbia Procurement Practices Reform Act of 2010, effective April 8, 2011 (D.C. Law 18-0371; D.C. Official Code § 2-352.02), the Council approves the extension of Contract No. CFOPD-17-C-009 for merchant services processing on behalf of the District of Columbia's Office of Finance and Treasury.

(b) The period of performance for the proposed multiyear option is May 19, 2026 through May 18, 2028. The proposed multi-year option cost is not to exceed \$10,000,000.00.
